BRIEF DESCRIPTION: The Alcoholic Beverage Control Board proposes to change regulations in Title 3, Chapter 305 of the Alaska Administrative Code dealing with requiring a business license during the application process.

The Alcoholic Beverage Control Board proposes to adopt regulation changes in Title 3, Chapter 305 of the Alaska Administrative Code, to make it a requirement to provide a doing business as name and a business license during the application process, including the following:

- 1. 3 AAC 305.045(c) is proposed to be amended by adding a new paragraph to require a doing business as name and business license during the new license and endorsement application process.
- 2. 3 AAC 305.050(c) is proposed to be amended by adding a new paragraph to require a doing business as name and business license during the renewal of a license and endorsement application process.
- 3. 3 AAC 305.070(c) is proposed to be amended by adding a new paragraph to require a doing business as name and business license during the transfer of location of a license application process.
- 4. 3 AAC 305.075(a)(2)(B) is proposed to be amended to clarify posting requirement language to require an applicant to post the doing business as name of the proposed premises during the application process



On August 26<sup>th</sup> Rexodus Pomrenke turned in a Declaration of Candidacy. The Declaration of Candidacy is attached in redacted form as Attachment A. All qualifications were reviewed by the City Clerk. All qualifications were able to be confirmed except for her voter registration status. When the City Clerk asked about her voter registration status, she was unable to produce a Voter ID Card or other evidence of being registered to vote. She signed the Declaration for Candidacy that she was registered. Thus, the City Clerk accepted the application as there was no current evidence that she was not in fact registered to vote.

On August 26<sup>th</sup> following the Declaration of Candidacy by Ms. Pomrenke, the City Clerk submitted a request to the division of elections requesting verification of Ms. Pomrenke being registered to vote with the State of Alaska and City of Nome.

On September 3<sup>rd</sup> the City Clerk received confirmation back from the division of elections. Attachment B is the verification form sent back to the City Clerk which is marked as NR for Not Registered. If she was registered the returned form would have had her Voter Number, registration date and precinct listed.

On September 4<sup>th</sup> there was a Candidacy Challenge made to her declaration of candidacy.

On September 5<sup>th</sup> A certified letter was sent to her asking her to come in within the following week to schedule a time to defend her candidacy. The letter is included as Attachment C.

On September 17<sup>th</sup> a letter was sent to Ms. Pomrenke notifying her of the City Clerk's determination that she was found ineligible to run for office. It is included as Attachment D. The reasons given were her not coming into the office to defend her eligibility and her not meeting the registered voter requirement before the candidacy declaration period closed. A notice was posted on the front door of the Public Safety Building which is being used for City Hall operations.

On September 18<sup>th</sup> Ms. Pomrenke came to the City Hall offices to file an appeal in response to the City Clerk's determination that she was ineligible to run for City Council Seat C and to show that on 09/18/24 she had registered to vote. Ms. Pomrenke agreed to have the appeal heard at the 09/23/24 Nome Common Council Meeting. The appeal is pursuant to NCO § 7.15.090.

You filed a declaration of candidacy for Council Seat C for the October 1<sup>st</sup> 2024 City of Nome municipal election. Pursuant to NCO 7.15.050, your eligibility to hold office has been challenged.

Nome Code of Ordinances 7.15.060(a) states:

If a person who has declared his or her candidacy for a municipal office is challenged, the city clerk shall recite to the challenged candidate the qualifications required for the declared office, and tender to the challenged candidate the opportunity to defend his or her eligibility under sworn oath.

The qualifications for the office of councilmember are set forth in NCO 2.15.020:

A qualified city voter who has been a resident of the city for at least one year immediately prior to taking office and who is not delinquent in payment of any undisputed city property tax, sales tax, utility bill or other financial obligation is eligible to be a member of the city council.

The qualifications to be a city voter are set forth in NCO 7.10.010:

A person may vote in a municipal election only if he is a United States citizen qualified to vote in state elections, has been a resident of the city for thirty days immediately preceding the election, is registered to vote in state elections, and is not disqualified under Article V of the Alaska Constitution. The term of residence is computed by including the day on which the person's residence begins and excluding the day of election.

You are entitled to defend your eligibility under sworn oath. As further set forth in NCO 7.15.060:

(b) If the challenged candidate chooses to defend his or her eligibility under sworn oath, the city clerk may question the challenged person on any subject matter tending to test his or her qualifications to hold office. The responses to all such questions shall be transcribed and reduced to a sworn affidavit, and the challenged candidate shall subscribe and swear to said responses in the presence of a qualified Alaska notary public.

(c) Any person who refuses to submit to questioning, or refuses to subscribe, swear or affirm to responses to such questioning, as provided in subsection (b) of this section, shall be rejected by the city clerk as a person ineligible to be a candidate for the declared office.

If you wish to defend your qualifications for candidacy, please contact the City Clerk to schedule a time for defense of your eligibility during the week of Sept 9-13 during the Clerks office hours of 8am-5pm. Please be prepared to provide evidence that you meet the qualifications for the office of councilmember set forth in NCO 2.15.020. If you have not scheduled a time for defense of your eligibility by September 13, your shall be deemed ineligible to run for candidacy for Council Seat C for the October 1<sup>st</sup> 2024 City of Nome municipal election.

The Contractor shall at all times observe and comply with all such regulatory requirements, orders and decrees; and shall protect and indemnify the City of Nome and its representatives against claim or liability arising from or based on the violation of any such regulatory requirement, order, or decree whether by the Contractor, Subcontractor, or any employee of either. Except where otherwise expressly required by applicable regulatory requirements, the City of Nome shall not be responsible for monitoring Contractor's compliance with any regulatory requirements.

## VI. <u>Permits, Licenses and Taxes</u>

The Contractor shall procure all permits and licenses, pay all charges, fees and taxes, and give all notices necessary and incidental to the due and lawful prosecution of the work. As a condition of performance of this Contract, the Contractor shall pay all Federal, State and local taxes incurred by the Contractor, in the performance of this Contract. Contractor is obligated to pay City of Nome sales tax on those portions of Subcontractor invoices that are charges for labor or materials rendered for the benefit of Contractor by any Subcontractor Proof of payment of these taxes is a condition precedent to final payment by the City of Nome under this Contract.

## VII. <u>Payment</u>

Payment will be made within 30 days of presentation of a suitably documented application for payment.

The Contractor warrants and guarantees that title to all material covered by any application for payment will pass to the City of Nome no later than the time for payment free and clear of any liens, security interests and further obligations.

Payment or partial payment may be withheld by the City of Nome if subsequent evidence or the result of subsequent inspections or test, nullify previous payments and/or if the Contractor has failed to fulfill or is in violation of any of his obligations under any provisions under this Contract.

#### VIII. Venue and Applicable Law

The venue of any legal action between the parties arising as a result of this contract shall be laid in the Second Judicial District of the Superior Court of the State of Alaska, and this contract shall be interpreted in accordance with the laws of the State of Alaska.

## IX. Option to Renew

Subject to budget appropriation, the City of Nome may elect to extend this agreement for one additional year per the terms of the Owner's solicitation.

# CITY OF NOME ORDINANCE NO. O-24-10-01

## AN ORDINANCE AMENDING CHAPTER 17.10.010 SALES TAX

WHEREAS, during the elections of 2022 proposition No.1 was introduced amending chapter 17.10 repealing the seasonal sales tax in The City of Nome; and

WHEREAS, the voters of the City of Nome voted in favor of repealing the seasonal sales tax; and

**WHEREAS**, the Common Council wishes to have this change reflected and clear within the Nome Code of Ordinances;

# IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOME:

**Section 1. Classification.** This is a Code ordinance.

**Section 2. Amendment of Section 17.10.010.** Section 17.10.010 of the Code of Ordinances of Nome, Alaska is hereby amended to read as follows [deletions are overstruck and new language is <u>underlined</u>]:

(a) There shall be levied and collected a sales tax of five percent of the selling price on all retail sales and rentals of goods and services in the city<del>, except as provided in NCO Section <u>17.10.020</u>, during the months of September, October, November, December, January, February, March and April. (b) During the months of May, June, July, and August there shall be levied and collected a sales tax of seven percent of the selling price on all retail sales and rentals of goods and services in the city, except as provided in NCO Section <u>17.10.020</u>. (Ord. O-16-10-09 § 1, 2016: Ord. O-03-07-2 § 1, 2003: Ord. O-93-6-6 § 1 (part), 1994)</del>

**Section 3.** <u>Effective Date</u>. This ordinance is effective upon passage.

This is being written on Thursday afternoon. There will probably be an oral update at the meeting.

First- thank you for this opportunity to return to service on behalf of residents of Nome. This will be a rewarding experience for me and hopefully a productive one for the community.

**Priorities**- When I got off the plane Monday my first priority was finding a permanent city manager. Three and a half days in there is a second "first" priority. Negotiation of a collective bargaining agreement between the City and the City of Nome Employees Association (APEA Local# 6141). This is an initial "top 2" list subject to Council input.

**CBA-** I hope to report orally on a proposed schedule but as of this writing have yet to coordinate with bargaining unit representatives. Step one on management side is formation of the management bargaining team. Union negotiations are not conducted in public. Council can expect executive session and special meeting requests as needed. Council and ASEA approval of a new CBA by the last council meeting in December should be a mutual goal.

**City Manager Search**- Council earlier directed using an executive search company. I prepared an RFP and have asked the HR Director to send it to 7 firms. Notice will also be advertised in the Nome Nugget on Thursday. The due date for responses is October 16. While we wait for responses I recommend the City also initiate its own recruitment through posting and advertising of the position locally, with AML and ICMA. Step 1 in that process is a review of the job description which dates from 2015 and is in your packet. Council should begin thinking about salary. The advertised minimum salary will be based on the initial contract for Mr. Steckman and will be DOE.

**City Hall HVAC-** The Contractor believes it will be possible to begin moving furniture and equipment into City Hall the week of October 14. The substantial completion inspection has been scheduled for November 4. Coordination of the move in will be a bit of a dance. Stay tuned for details.

**Kawerak Lease of Monofill Building-** Next step is development of the legal description to include in the lease agreement. Once the agreement is finalized it will be brought to Council for approval by ordinance. Current target date is for final approval of the ordinance by either the second October or first November council meeting.

**Towing Contract-** A request for bids for winter towing of vehicles in public rights of way has been advertised.

**Fee Schedule Update-** Targeting bringing an updated (i.e. increased) fee schedule to Council at the first council meeting in October.

#### Summary:

The City Manager serves as the Chief Administrative Officer of the City of Nome government. Plan, organize, direct and coordinate administration of city government in accordance with policies, operating principles, and ordinances determined by the City Council. Supervise the enforcement of municipal law and carry out the directives of the City Council. Prepare and submit an annual budget and capital improvement program for consideration by the City Council and execute the budget and capital improvement projects as adopted.

Monitor and make reports on municipal finances and operations as required by the City Council. Exercise custody over all real and personal property of the municipality. Serve as Personnel Officer of the City. Serve as Port Director, the Chief Administrative Officer, of the Port of Nome.

Perform other duties required by law or by the City Council.

#### **Essential Duties:**

Essential and other important responsibilities and duties may include, but are not limited to the following:

Prepare the annual budget and submit estimates to the City Council for approval. Monitor the budget and report to the City Council on the financial condition and the needs of the municipality. Prepare annual financial and administrative reports. Develop capital and short-range project plans, and prioritize and assign projects to optimize budget funds. Assure the financial soundness and integrity of the City to assure its capability to meet commitments and to maximize the delivery of services to citizens.

Provide direct support to the members of the City Council. Assist Council Members with a variety of activities, providing leadership and information as requested; assist Council Members in drafting policies, facilitating the development of City plans, regulations and ordinances. Facilitate strategic planning with the City Council to establish long-term goals. Develop a long-range plan

for capital improvements for facilities; study and evaluate transportation problems and alternatives.

Assure proper coordination of City activities with legal services.

Ensure the care and custody of all municipal property, funds and assets.

Plan for future development of municipal areas to provide for population growth and expansion of public services. Provide leadership and direction in such areas as annexation, major public works projects and long range capital projects.

Execute and enforce all ordinances, resolutions and motions and policies of the City Council and administer, negotiate and manage all City contracts, leases and grants. Provide direction and make decisions regarding the contracting of City services, assure open and competitive bidding process in accordance with Council policies and directives. Negotiate formal and informal agreements between City, State and Federal governments and private interests as issues arise.

Serve as the City of Nome Incident Commander.

Attend and participate in City Council meetings. Keep Council informed on matters that may impact future policy decisions. Required to attend evening meetings and may need to work on holidays and weekends as needed.

Serve as Personnel Officer, unless the City Council authorizes the City Manager to appoint a Personnel Officer. Direct supervision is exercised over the work of all Department Heads within the City and subsequent responsibility for all personnel within the municipality. Supervise and coordinate the personnel policies and practices of the City. Respond to grievances and oversee all personnel actions. Appoint, remove, supervise and coordinate the work of the Department Heads and administrative staff as provided by state laws or local ordinances. Including supervise and evaluate the performance of assigned staff; interview and select employees and recommend transfers, reassignments, termination and disciplinary actions. Plan, coordinate and arrange for appropriate training of staff. Supervise Municipal Clerk functions including elections, the making and safeguarding of records and publication of notices. Direct departmental operations; evaluate issues, and recommend solutions.

Provide for Risk Management through the development of guidelines to assist in loss prevention and control.

Maintain cooperative working relations with the City departments, and outside agencies, serve as liaison between various organizations, agencies, and commissions; serve on committees, task forces and other groups to coordinate municipal services programs. Including acting as a liaison to Nome Joint Utility Systems, Nome Public Schools, Nome Planning Commission, Nome Port Commission and Nome Museum and Library Commission and other ad hoc committees.

Maintain close contact with community groups to represent the City of Nome; develop community relations, programs and policies; represent the City in neighboring jurisdictions, governmental bodies and the news media. Meet with the public, business, service and social organizations to answer questions, advise members of the community of municipal plans and action; and, to listen to citizens' concerns. Provide information and assistance to individuals and firms which would contribute to the economic diversification of the City. Promote citywide governmental functions and activities to continually improve public knowledge, understanding, confidence and support on behalf of the City Council.

Represent the City of Nome at Federal and State events and actively work in the State legislative process with the City lobbyist and the Mayor. Communicate with State and Federal officials and legislators to present the City's viewpoint on pending administrative or legislative actions.
