This past weekend with the port of call of the Cruise Ship was the busiest he's ever seen it. The size of the cruise ship was taken into account along with this being a Port of Call for the ship which has visitors that come in prepared to spend money versus other ships that use the port for refueling and restocking their ships. There were a lot of positive comments made about the receptiveness of the City of Nome and the Lions Club Chicken Fundraiser. The City Sponsored the CAC event in the parking lot across from City Hall which was a success. The City also sponsored the Music Fest the week before by supplying tables and chairs. Great weekend with great weather and boat races and more chicken sold. A thank you was made to the citizens of Nome for the Spring Clean Up. There was a lot of households that took part. The move of City Hall was addressed and where the various parts of City Hall would temporarily be housed during the Asbestos and Lead abatement and HVAC renovations that will be taking place. Moving will start July 1st. The Committee and Council meetings will all take place in the Richard Foster Room as other facilities do not have all the capabilities that are needed to run meetings. Sorry for any inconveniences made to the public.

There are currently 3 vacancies with the Police Department. C. Henderson asked what had changed. Suggestion was made that having an Hr. Director has helped. The City Manager suggested that improvements on our city facilities and on our public image has helped along with the exposure of vacancies. Ongoing accreditation is being made and C. Henderson highlighted the current efficacy of the Police Department Staff. C. Johnson expressed the importance of having PD Officers that are Nome based. City Manager Steckman stated that there are housing challenges which contribute towards having full time staffing positions versus employees that come and go.

An update was asked by C. Henderson on an RFP for a towing contract. The City has borrowed fencing from NJUS to construct and impound yard and the City Clerks office is working on an RFP to put out into the community to assess interest of the private sector.

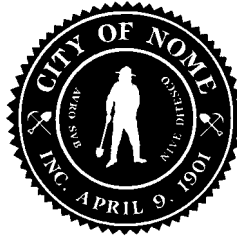


We eagerly await action by the Corps of Engineers to get to awarding the contract for the Arctic Deep Draft Port at Nome. We trust the latest change to the timeline is the last! We do appreciate the support from Governor Dunleavy and the administration, as well as the Legislature. You deserve much thanks and credit for your personal support, as well as that of your department.

The City of Nome has discussed impacts of the project, including the potential to residents and infrastructure, once activity gets underway. One key aspect will be the movement of rock from the rock quarry. We believe it is envisioned some quantity of rock could be moved via water from the Cape Nome Rock Loadout Jetty to the Port of Nome Causeway. The vast majority, however, will likely be transported by truck.

The City supports trucking and transportation concepts that can reduce the number of trips required to move materials from Cape Nome to the project site. We will appreciate contractors seeking out such options to that end. Should the Department be presented with alternatives requiring special consideration to reduce the number of trips on roads and through town, we believe this would be beneficial to Nome residents.

Dear Nome Common Council,

I work for the Alaska Department of Environmental Conservation's (DEC's) Brownfields Program. Brownfields funding helps communities redevelop underused or abandoned properties where contamination may be hampering redevelopment. Our funding program can help provide planning, site assessment, and cleanup services to help address contamination issues and redevelop properties for public reuse. Every year, we help about 10 communities across Alaska move their brownfields projects forward through site-specific technical assistance and fieldwork.

This fall, the DEC Brownfields Program has the opportunity to apply for an EPA brownfields assessment grant (up to \$2 million). This application would require us to identify three target areas across the state and five priority sites on which to conduct site-specific work. We are hoping to include Nome as a target area and work with the City to identify one or more sites that are priorities for the City where brownfields funding could help spur the reuse and redevelopment of underutilized properties in your community.

I will be in Nome on July 15th and 19th for other business but would love to schedule a meeting with you and members of the City governance team to discuss this grant opportunity and other DEC Brownfield funding programs that could help support Nome's efforts to address its brownfield sites. Thank you for your time and consideration. Looking forward to working with the City of Nome on this and other brownfields projects in the future.

Proposed Permit Coverage:

The permit authorizes discharges of wastewater from the IPOPOP LLC silt curtain containment system doorway into the Bonanza Channel. The Bonanza Channel Placer Project is located approximately 28 road miles east of Nome along the Nome-Council Highway in the Bonanza Channel. IPOPOP LLC claims and operations are protected from the Bering Sea by an approximate ½ mile-wide southern boundary barrier island traversed by the Nome-Council Highway. The permit includes a mixing zone for turbidity and settleable solids.

Tentative Determination:

DEC has tentatively determined to issue a discharge permit for the activity described above.

Public Comments:

Written comments or requests for a public hearing on the APDES draft permit must be submitted prior to the expiration of this public notice.

Written comments and requests should be directed to the attention of the DEC contact/permit writer at the email address or postal address identified above.

All comments should include the name, address, telephone number, and email address of the commenter and a concise statement of comment on the permit condition(s) and the relevant facts upon which the comment is based. Comments of either support or concern that are directed at specific, cited permit requirements are appreciated. Mailed comments and requests must be postmarked on or before the expiration date of the public notice.

DEC will consider all comments when making the final decision and will respond to received comments in a Response to Comments document issued when DEC issues a final permit. The Response to Comments will be made available to the public.

Any interested person may submit a written request for a public hearing if no hearing has already been scheduled. A request for a public hearing shall state the nature of the issues to be raised, as well as the requester's name, address, telephone number, and email address. DEC will hold a public hearing whenever DEC finds, on the basis of requests, a significant degree of public interest in a draft permit. DEC may also hold a public hearing if a hearing might clarify one or more issues involved in a permit decision or for other good reason in DEC's discretion.

DEC will transmit the final permit, fact sheet, and Response to Comments to anyone who provided comments during the public review period or requested to be notified of DEC final decision.

Subject: DRAFT Department of Defense (DoD) Arctic Strategy Engagement Strawman

The following **DRAFT** strawman is provided to PD DASD AGR to respond to proposed Alaskan/U.S. Arctic Region engagement in support of DoD Arctic Strategy roll-out and onward implementation.

Overall construct: Conduct a number of community level roundtable discussions across Alaska where there are important local defense interests, inclusive and with particular attention to Alaskan Natives in order to provide orientation of the pending release of the updated DoD Arctic Strategy.

Recommendations are as follows:

Format: In-person roundtable with option for call-in for regionally invited participants. Recommended size should be approximately 20-30 participants. Each roundtable should be approximately 2/2.5 hours, in order to provide a briefing of the key points of the strategy and a chance for questions and discussion. Additional individual meeting opportunities may be coordinated with local and regional community leaders.

Desired outcomes include community engagement and open a dialogue on the updated DoD Arctic strategy with invited guests. This includes listening and learning about localized defense concerns.

Key themes to highlight include:

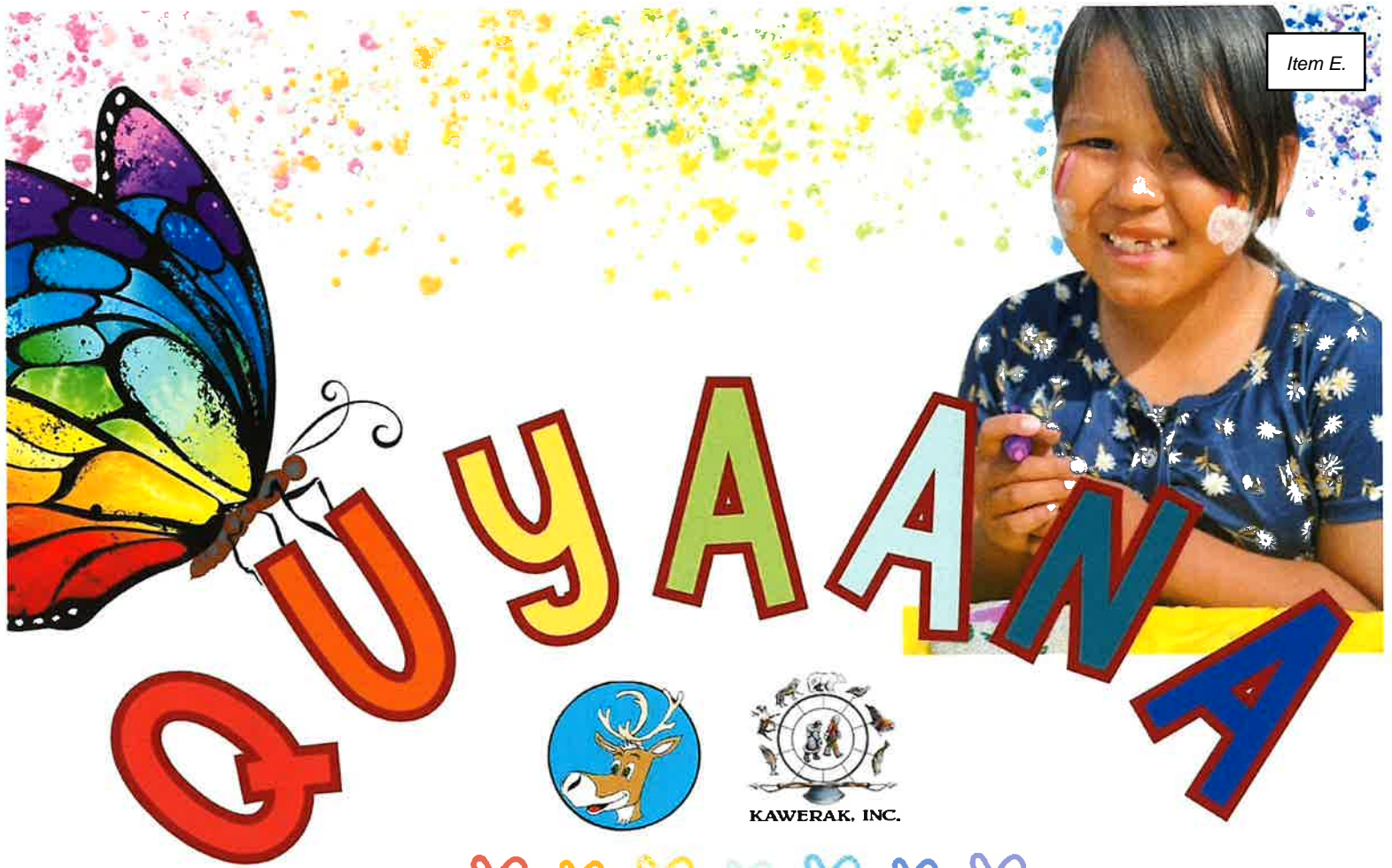
1. The updated DoD Arctic strategy is a national level plan, but oriented and constructed to **internally guide** DoD's military departments and Combatant Commands.
2. The DoD Arctic Strategy nests under the National Security Strategy (NSS), National Defense Strategy (NDS) and supports the security pillar of the National Strategy for the Arctic Region (NSAR).
3. The Strategy is oriented to address U.S. national security interests across the pan-Arctic region, inclusive of the U.S. Arctic.
4. As an internally oriented department strategy, the document has been developed and coordinated for associated internal action within DoD. However, informing Alaskan communities with key defense interests is considered needed and helpful for onward implementation.

**A RESOLUTION DESIGNATING DANIEL GRIMMER
AS ACTING CITY MANAGER
FOR JULY 13TH THROUGH JULY 16TH, 2024**

WHEREAS, NCO 2.35.030 provides that “During the city manager’s absence or disability, the city council shall designate by resolution an official to act as city manager”; and,

WHEREAS, modern advancements in communications technology allow individuals to perform duties from locations other than a fixed office, so job responsibilities and functions can be performed from anywhere on the globe, but on occasion it is necessary, prudent and healthy for an employee to be able to “unplug” on occasion; and,

WHEREAS, Glenn Steckman, City Manager believes it prudent to have an Acting City Manager available in town during this period to be able to address any necessary matters promptly; and,

WHEREAS, the City Manager recommends Daniel Grimmer, be designated Acting City Manager with authority to perform powers and duties of manager during the period;

NOW, THEREFORE, BE IT RESOLVED that the Nome Common Council accepts the manager’s recommendation and appoints/designates Daniel Grimmer Acting City Manager for the period of July 13th through July 16th to perform delegated duties and assume the responsibilities as provided in NCO 2.35.020, elsewhere in the Code, and in Alaska Statutes – Title 29.
