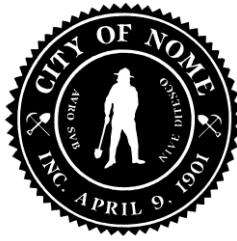

NEW BUSINESS

A. Discussion presented by Commissioner Ford re: A Complaint with Commercial Zoning Uses,

C.Ford mentioned she had six people reach out to her and there are no permits for the pads put down, working after hours making a nuisance for other residents. Commercial Zoning states you can have junk if you're using it for the use of business. Joe Bernum is the owner and it is for shell-fish fishing and there is nothing registered with the state. He does not own a permit. Brooks mentions that it was a resolution to sue the property owner because he had not obtained the permit. He then came in and got his permit. We cannot speak without having a permit application and full investigation to qualify as a commissioner's permit. 18.10.110A states that each violation is given \$100 per day. C.Lust says the city is now aware of the issue and that due process would be good. C.Smith says it should be time to move on this now. C.Ford says her goal is to bring it to the cities attention and documented that she has brought the citizen's concerns forward. They gave her permission to use their names. C.Lust says the planning commission should do this as a follow-up agenda for next months meeting and see where it's at.

UNFINISHED BUSINESS

A. Planning Memo RE: Downtown Zoning Progress & Crew Camp Ordinance Progress,

Erin has couple updates. I've been working with the city attorney, city manager and city clerk to finalize the approval process for the downtown zoning districts. Will have the first planning meeting for adoption process in January which requires public notices and if that is ready, we'll have a meeting in March with the Nome City Council. We'll be having some discussions. Brooks and I have been brainstorming. C.Smith says it looks great and C.Piscoya says she likes it.

A. City Manager Report,

Brooks mentions he does not have much to report but what the planner has placed in front of you. Brooks mentions to the Planning Commissioners that his contract ends Monday, 16 December 2024 and is not on extension and won't be back to their next meeting in January. There is still no successor but there is still time.

B. Building Inspector Report,

Cliff says the continue of sunshine subdivision; the owner got the water and sewer working. Atlas tower adjacent to the high school has been completed and working with the subcontractor to demo for the GCI tower. Cliff addresses to C.Smith that he did not know he can issue citations and it's a work in progress. He's been working with Dan and Brad on the myGov website. A lot of times people run out of money and it can go on for 2-3 years.

COMMISSIONER'S COMMENTS

C.Piscoya – We should talk to the Nome City Council for recommendation to extend his (Brooks) contract. She says this was a very interesting meeting. And with these complaints; they should be brought up to the council and also recommended to speed things up.

C.Lust – He says he has more appreciation for the Chairman Hughes in conducting the meetings and he appreciates everyone. C.Lust is proud of the Tower that was put up around the High School. He thanks Brooks for being here.

C.Smith – He thanks Ken for being on track. Hoping we can get Brooks to stay longer. He mentions that he appreciates Cliff doing his work. He suggests that the building inspector job title be changed to Code Enforcement Officer, so he can distribute citations to the residents that are breaking the municipal codes and the public, as a whole, has a better idea of his job description, along with himself.

C.Ford – She mentions to Cliff that she doesn't envy his job and she knows it is hard when he is hobbled. The town is great. Thanks Brooks for being here.

C.Hughes – says he spoke to someone about a property that belonged to 2-3 heirs who went through a lot of problems, spent a bunch of time to get the title clear to get the property up and running. A lot of people in this situation. He is hoping to assist these folks and this would be one way to help them out and clean up some problems. C.Hughes pointed out the Land Bank; attempted to review the state laws that created land banks. Wondering if the Nome Planning Commission has the same opportunity, he is unclear. There is some national code that creates an Alaska Land Bank. A lot of the probate stuff could perhaps be sped up if there was a lot of pressure applied. If he is here for the next city council meeting he will bring up this issue. Thanks Brooks. And he thanks his fellow commissioners for attending the meeting.

Subject: Determination of City Council re: Sales Tax Penalties and Interest

Mr. Rodney Jones has asked for forgiveness of the Sales tax penalties and interest for Nome Checker Cab for the years of 2021-2023. This is in response to the NCO requirement to be current on his taxes for this business in order to have his cab licenses renewed.

Earlier this year Mr. Jones had meet with City Manager Glenn Steckman about evaluating what Nome Checker Cab owed in unfiled sales tax for the tax years of 2021-2023. Mr. Jones had expressed some difficulty in using the LocalGov system.

Since that time Nome Checker Cab has registered with the LocalGov system. Mr. Jones has explained that the reason he has not yet reconciled the past due sales tax is due to him having multiple properties that were on this years foreclosure list for which he was making an effort to make payments.

Mr. Jones made payments on the principal Sales tax amounts owed for 2021 and 2022 and 2023. He has paid off the principal tax amounts for those years.

The City Clerk is asking for the Nome Common Council to make a determination on approving the forgiveness of the 2021-2023 Sales tax penalties and interest in the amount of \$4,120.56 for Nome Checker Cab per Mr. Jones request.

**A RESOLUTION OF THE NOME COMMON COUNCIL RESOLVING TO RELEASE
THREE TAXI CAB LICENSES AND AUTHORIZING THE CITY CLERK TO
DETERMINE ELIGIBILITY TO APPLY FOR A LICENSE BY LOT**

WHEREAS, Nome Code of Ordinances (NCO) regulates the operation of taxi cabs within the City of Nome, requiring the proper licensure for both company and driver; and

WHEREAS, the Nome Code of Ordinances NCO 3.10.090 states that in 2005 it was determined that thirteen cab licenses shall be issued in the City; and

WHEREAS, two taxi cab licenses were rescinded from the operating taxicab companies by way of Resolution 17-03-01; and,

WHEREAS, six taxi cab licenses are currently held by Nome Checker Cab; and

WHEREAS, five taxi cab licenses, (T-11031-A, T-11031-B, T-11031-C, T-11031-D, & T-11031-E) issued to Mr. Kab A2B in 2020, were revoked November 17, 2020; and,

WHEREAS, NCO 3.10.090(e) provides for a process upon the lapse or revocation of a license; and,

WHEREAS, upon revocation or lapse of a license, the Council shall determine whether to reduce the number of authorized licenses; and,

WHEREAS, if the number is not reduced, the lapsed licenses shall be determined by lot in a public drawing conducted by the City Clerk.

NOW, THEREFORE, BE IT RESOLVED;

1. That the Nome Common Council has decided to release three licenses from those that were previously revoked; which brings the total of approved licenses to nine.
2. The City Clerk's Office is hereby authorized to hold a public drawing by lot, as provided by Nome Code of Ordinances Section 3.10.090(c), to determine who is eligible to apply for any of the 3 previously revoked licenses.

**A RESOLUTION AWARDING THE CAPE NOME JETTY REPAIR PROJECT TO
DUWAMISH SERVICES, LLC**

WHEREAS, the Jetty at Cape Nome is part of Nome's Port Facilities and serves as an important alternate facility for the movement of cargo and equipment, plus the exporting of gravel, armor stone, and other aggregate products; and,

WHEREAS, the Cape Nome Jetty was significantly damaged in the September 2022 storm, and since that time, the facility has not been able to operate for the purposes it was designed; and,

WHEREAS, the City of Nome (City) has been working with the Alaska Department of Homeland Security Division of Emergency Management (ADHSEM) and FEMA to finalize a scope of work, and secure funds at a sufficient level to provide the necessary post-storm disaster relief; and,

WHEREAS, ADHSEM and FEMA approved a revised Project Worksheet (PW005), advising the City on 7 Oct 2024 that \$9,353,557 in project funds had been obligated by FEMA, with an Obligating Award Document (OAD) forthcoming from ADHSEM, thereby allowing the City to move forward with publicly bidding the project as was done on 7 Nov 2024; and,

WHEREAS, the OAD funding award of \$9,353,557 was ultimately received by the City on 16 Jan 2025, prior to the scheduled project bid opening of 30 Jan 2025; and,

WHEREAS, three bids were received and publicly opened on 30 Jan 2025, with Duwamish Services LLC being deemed the lowest qualified responsive bidder at \$7,359.935; and,

WHEREAS, the City of Nome wishes to move forward with the project by awarding the bid of \$7,359,935, with all costs authorized under FEMA's Disaster Declaration DR-4672-AK.

NOW, THEREFORE, BE IT RESOLVED that the Nome City Council awards the Cape Nome Jetty Repair Project to Duwamish Services, LLC for \$7,359,935.

Re: Port Project Status – Feb 2025

Administration:

In preparation for the next budget cycle, and in addition to the aggressive account collections currently underway, staff are focusing on budgetary needs, such as procurement for standard consumable items, necessary maintenance and repairs, improvements, personnel and training, as well as costs for meeting compliance of specific operational infrastructure inspected by various agencies.

The City had planned to send a small delegation to Washington DC from 3-5 Feb 2025, to meet with the Alaska Congressional Delegation (CODEL) and various committee staff within both the Senate and House. Although due to weather and illness, neither the Mayor or myself were able to travel. Fortunately, Megan Onders had already arrived in DC, allowing us to develop a strategy with Jay Sterne (City lobbyist) to hold hybrid meetings as needed. The Mayor and I were able to join meetings with all three of the CODEL offices via phone or Zoom. Overall, the trip was a success, with a focus on the port expansion progress for re-solicitation, funding and schedule, water & sewer needs, and coordination for other 2025 priorities identified by the City. A follow-up trip anticipated in the coming months.

Strategic Development Plan:

PND and Corvus continue working on the Strategic Development Plan, incorporating input from the public, users, port commission and city/port staff. This guidance will inform the final port (Phase C), and reflect a solid long-range plan for future port development. An updated draft will be shared in a Port Commission Work Session for review.

Causeway:

Arctic Deep Draft Port – Nome Modifications (Construction Bid Award):

The USACE and City design teams have been diligently working on the revised bid solicitation, with a 100% package compiled the last week of Jan 2025. This package is now going through several mid and senior-level reviews at USACE, and expected to be approved for release by the end of Feb 2025, with an award in late summer 2025.

Local Service Facilities (LSF) Inspection Integration:

The City design team has worked closely with the USACE team in achieving completion of the recalibrated package known as Phase 1A. This has been done on an expedited schedule in order to maintain forward momentum.

U.S. DOT Maritime Administration (MARAD) – Port Infrastructure Development Program (PIDP) Grant Pre-Award:

Prior to the December holidays, the required Title VI documents were drafted and submitted to PIDP staff, City Admin and HR for review and comment. Discussions continue on the necessary content for this package, with briefings scheduled with PIDP staff on 12 Feb 2025, and subsequent follow up with City Admin/HR. This will then allow the \$11.25M grant agreement to be executed, along with a separate funding agreement for the \$1.025M that Rep Peltola successfully placed into the FY2025 USDOT budget to supplement the PIDP award to Nome. More to come as this moves forward...

Harbor:Inner Harbor CAP 107 Study (Deepen/Widen the Inner Basin):

The USACE has now advised that this project no longer qualifies for a Continuing Authorities Program (CAP) 107 Study path due to construction costs exceeding the \$10M funding cap. The Alaska District is now recommending pursuit of a General Investigation (GI) Study, which was the path used for the port expansion feasibility report. We are working with the project team to determine next steps on this path, along with the local cost-share and proposed schedule.

Snake River Moorage Facility:

City staff are standing by to coordinate with USDOT/RAISE program personnel to identify pre-award requirements that will need to be met before execution of a grant agreement, as well as discuss specific language necessary to inform the project grant agreement. As federal agency funding programs are changing rapidly at this time, we have been advised by RAISE personnel that they will reach out in the near-term to begin the agreement process.

Port Industrial Pad:West Nome Tank Farm (WNTF) - Property Conveyance:

Based on continued delays with finalizing the conveyance documents, we contacted the Alaska Congressional Delegation last week to look into the matter with USAF/HQ. Thankfully, this inquiry brought benefit to the issue as the final drafts of the files were received the very next day. These latest docs are under final review by ADEC, state legal staff, and our City attorneys to ensure nothing has changed in the past year since last review. Once the local and state reviews are complete, the USAF is required to file the Environmental Covenants and Quitclaim Deed documents with the Alaska Recorder's office – which will actually convey the 7-acre property.

Thornbush Laydown Site Development (TBS):

Costs are being compiled for pursuing grant funds to complete the development of the remaining 8.5 acres of the 18-acre parcel. Several funding vehicles are accepting applications at this time, and we are hopeful that we will identify one that is aligned with this work. This additional laydown property is critically needed for staging of cargo and equipment, along with stockpiling gravel and rock, needed for the port expansion as well as for exporting to construction projects throughout the region.

Port Rd. Improvements (ADOT Project cost-shared with City):

This state STIP project has been postponed to approximately 2030 to avoid conflicting with the heavier truck traffic during the port expansion, and to facilitate a more productive repair following the project.

FEMA DR4672 Merbok Recover Projects:Cape Nome Jetty Repair:

The City has received and signed the Obligating Award Document (OAD) securing the necessary disaster funds to allow for award of the repair project. Three bids were received and opened at 3pm on 30 Jan 2025, with the lowest qualified bidder being Duwamish Services, LLC., in the amount of \$7,359,935. Contract documents are being compiled for execution, with work scheduled for the 2025 ice-free season.
