UTILITY MANAGER'S REPORT

- A. Activity Report: September 14 24, 2021.
 - Morton noted the fuel delivery would be wrapped up within a day. He explained that Marty Silvernaill would be retiring soon and that Lucas Bauman has been promoted to begin the transition. Morton noted the old, smaller wind towers have been removed by TelAlaska.
 - He discussed details about the Tank Farm pad transition and the replacement of all old electrical meters in town.
 - Council Member Brown asked what the plan was for when the line crew runs into defficient meter boxes.
 - Morton explained there was a meter audit a few years ago and letters were sent out asking for corrections. He noted issues would be addressed on a case by case basis.
 - Council Member Mark Johnson asked about the Moonlight Springs project.

 Morton explained the difference in elevation, giving about 100 ft of head energy, and the efforts to use that difference to decrease pump related power costs by about \$30,000 a year.

CITY MANAGER'S REPORT

- A. Activity Report: September 14 24, 2021.
 - Manager Steckman presented his written report, highlighting a successful U-Call, We Haul. He noted the vehicle bounty would stay in place until November 1st or the first snowfall. He announced Mimi Farley would be joining the Finance Department. He discussed the current status of Covid-19 in Nome, breaking case numbers down by vaccine status. Manager Steckman noted there were 43 sexual assault cases in Nome in 2021; 32 have closed and 11 are still being investigated.
 - Council Member Topkok asked about the Public Safety Commission meeting and current vacancies.
 - Manager Handeland explained he had one pending nomination and Manager Steckman noted recent meetings.
 - Council Member Mark Johnson asked for, and Manager Steckman gave details on Phase VII of CARES Act funding.
 - Port Director Baker discussed the status of the launch ramp replacement project, explaining the concrete panels and beams were about 50% built. She explained a delay in the project, pushing substantial completion back to 9/30. Due to issues over the weekend, its now looking like substantial completion will occur on 10/4, allowing haul out on 10/5.

- 1. Rhonda Schneider, Nome Community Center, thanked Manager Steckman and the Council for updating the contract. She explained some ways the move into XYZ advanced NCC's programs and furthered the partnership between NCC and the City of Nome. She discussed a project that would construct a \$5.5 million building to provide 15 units for chronic homeless inebriates.
- 2. Diana Haecker announced the upcoming candidate forum on Wednesday evening in Council Chambers, sponsored by the Nome Nugget, KNOM and the Nome Chamber of Commerce.

ICMA:

I attended two days of workshops at my professional organization the International City/County Managers Association. This year most of the workshops focused on either COVID-19 and its financial implications or the issue of homelessness affecting municipalities.

Rec Center:

The new boiler is on the way. Last Friday Carl Emmons, RSA Engineering and city representatives met at the Rec Center to make sure everyone was in agreement on how to proceed. RSA Engineering, as a sub for Bristol Engineering, will develop the drawings to support the concrete base and the electrical and plumbing plans for the project.

Community Center:

Because it was determined by Yukon Fire that our alarm system needed to be replaced, the city solicited quotes which were well above the \$50,000.00 level. Bristol Engineering is now developing the bid specs with RSA Engineering in order to get an apples to apples quote. The goal is to have the system replaced this winter.

Employee Handbook:

An update of the employee handbook is back on the front burner. Janice and I are working on a first draft. We will then work with department managers and the union before placing this issue before the council for discussion and approval.

School employee and Public Safety Housing:

Because of the rapidly rising costs for materials, the original estimates are below the most recent pricing of the project. Working with the NSD, we are exploring value engineering and other options. On the horizon more housing will be needed for the hospital, the port expansion and Graphite One. I believe buying existing housing is not the long-term solution to the need of more housing units in general.

RFP for a new/upgrade radio system:

It has been suggested to find a consultant to provide direction on what is needed for the city instead of soliciting and being provided varying solutions that we would need to evaluate. Gray Harrison is working on this with Doug Johnson and John Handeland.

Emergency Order:

The order will be on your agenda Monday to accept, modify or end. As an FYI, the Order is set to sunset on October 15 at mid-night. NSHC was supportive of the order because cases had risen above 30 residents. I am watching to see if the case count goes down below 30 to make any further decisions or recommendations.

New NPD Vehicle:

A new F-150 police vehicle has arrived to supplement our police fleet. The ability to order new expeditions is still not possible at this time.

Audit RFP:

The request for audit proposals will be soon going out. The goal is to have them on your agenda is December 13, 2021.

Workshop on Finances:

Staff are requesting that a workshop on finances not occur until November because the staff is tied up with the closing of the 2020/2021 books.
