

Project Restart:

With the pilings completed last October, the project halted for the winter with all of the framing materials stored on site for an early spring restart. The winter was harsh and delayed the start by a few weeks. When crews arrived, enough snow had melted allowing access to the stored materials. Framing began in May with workers on the ground in working in cold, wet conditions with energy and enthusiasm at the newest structure in Nome began to take shape.





Imagine the surprise when workers arrived at the construction site to find a two inch layer of snow covering their building materials on June 1st!! Throughout those early months of the building season, workers had to deal with high winds, lots of rain, mud and cold temperatures. But, the late-season snow fall was something for them to chuckle about. Hard work and long hours produced the framework while Nome residents watched with anticipation to see what the structure would look like.

The weather in July and August did not provide much better working conditions, however, the work soon moved to the inside of the building where framing of the interior partitions began to be noticeable. Electrical, plumbing and other rough construction on the inside of the building gave specialized workers their opportunity to work under roof. The project has been on a fast and steady pace toward completion!





Apprenticeship:

One of the important components of our building project was to take advantage of having an impact on the local community by offering opportunities for locals to learn from experts. Job training is very limited in rural Alaska where the trend is to hire skilled workers from outside the area for specialized work due to the small pool of specially trained contractors and builders in Nome.

Contractors and subcontractors are working alongside some local hires to share knowledge and expertise, to give them experience, and to help them develop skills that they may use in the future to benefit our local community.

In the second quarter of 2023 alone, three individuals had the opportunity to work with three different contracting companies with a total of 929 work and training hours.

Timeline:

Since the very beginning of our project design, the goal for completion of the project was October 31, 2023. In spite of the challenges of construction in rural Alaska where shipping of materials depends on the barge schedule, where weather limits the construction season and where skilled workers come from outside the area, the project has remained on schedule. We expect to reach substantial completion, satisfy inspectors, and receive our occupancy permit on our around that projected completion date. We anticipate full occupancy by year end.

We will be able to house our first tenants before the most severe winter weather hits Nome!

<u>Memoriam</u>

It was with sad hearts that we learned of the lost life of one of the early crew members in a boating accident. Devon Betker was among the first group of workers in the spring to re-start the project. While waiting for the roofing materials to arrive on the first barge of the season, the crew returned to their homes in the Anchorage area for a week. It was during that time that the accident occurred. The rest of the crew attended services before returning to Nome without their coworker. Devon was a skilled carpenter with Orion Construction.

AN ORDINANCE AUTHORIZING SALE TO AK DOT&PF OF PARCELS ADJACENT TO SEPPALA DRIVE FOR ROAD PROJECTS

WHEREAS, the State of Alaska, Department of Transportation and Public Facilities ("DOT&PF"), in cooperation with the Federal Highway Administration, is preparing a project to reconstruct Seppala Drive from the Nome airport to downtown Nome ("Project"); and

WHEREAS, the purpose of the Project is to improve safety and pedestrian facilities and address poor pavement conditions and drainage issues;

WHEREAS, the Project requires certain parcels of city-owned land, more specifically described below ("Property"); and

WHEREAS, DOT&PF has determined that the fair market value of the land is \$32,000 for acquisition of the 29,700 square foot Property; and

WHEREAS, NCO 2.10.030(b) provides that the city council may, by ordinance, provide for the disposal of any interest in real property to a municipal, borough, state or federal entity, or to any other entity providing a necessary public service without seeking bids and for less than the current assessed value or current appraised value of that interest in real property; and

IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF NOME:

Section 1. <u>Authority</u>. This ordinance is adopted pursuant to authority granted by NCO 2.10.030(b).

Section 2. <u>Classification</u>. This is a non-Code ordinance.

Section 3. <u>Findings</u>. DOT&PF seeks to acquire the property for public transportation use, a necessary public service.

Section 4. <u>Authorization to Convey Real Property</u>. The below-described real property may be conveyed by quitclaim deed to DOT&PF, provided that such quitclaim deed shall specify that the interest of the city being disposed of reverts to the city in the event the real property disposed of is not being used to provide public transportation:

Parcel 4

WHEREAS, the Council shall appoint two qualified electors to act as clerks of the election; and,

WHEREAS, the Nome City Council hereby authorizes the following qualified electors:

WHEREAS, many municipalities set the wages of their election workers at the same rate of pay as the State of Alaska pays its election personnel, which is currently \$10.00 per hour for Judges and \$9.50 per hour for Clerks.

NOW, THEREFORE, BE IT RESOLVED that the City Council approves these electors and, by this resolution, hereby sets the compensation for the election personnel of the 2023 Municipal Election \$16.00 per hour for Judges and \$15.00 per hour for Clerks).

ATV Safety Enforcement Month:

Starting October 1, the NPD will begin enforcing safety rules and regulations for city and state roads. Alaska has the highest Traumatic Brain Injury cases in the United States. Flyers were distributed to tribal governments, Alaska Native corporations, the school district and businesses. The flyer was also posted to the city Facebook page and the Nome Nugget advising residents and visitors the rules of the road when operating an ATV.

Cruise Ships:

The past two weeks businesses have seen hundreds of visitors touring Nome. The Carrie M. McLain Museum was opened special hours to host the visitors. In addition, the Richard Foster Building Community Room hosted a local craft fair for the visitors. The Visitor Center attracted hundreds of visitors with their new improved visitor experience.

The last two cruise ships of the season, unfortunately, will only transport their passengers directly to the airport with no planned local activities.

U.S. Coast Guard:

The Local Sector Coast Guard Commander, Captain Culpepper visited Nome this past Wednesday. Joy then hosted a familiarization tour of the Port for the sector command staff.

U.S. Corps of Engineers:

All of the paperwork has been submitted to the Corps. The PPA has been signed.

Tax Conference:

I will be attending a two-day tax conference being held by the AML on Thursday and Friday this week.

Nome Fall Clean-up:

The Fall Clean-up saw 124 visits to Mono-fill by homeowners, 42 pick-ups of household bulk items from homes through the U-Call, We-haul service, 11 vehicles removed and two dump truck loads dropped off at OSJ.

Public Works Building:

Estimated losses from the fire are expected to be more than \$800,000. Repairs to the building will not start until then next summer. Because of this the top floor of the building will be buttoned up for the winter. Staff will continue to use the first floor and continue to work out of the snow dump facilities. Iron Dog also will be able to use the building for their event

Snow leases:

Snow leases, that need to be renewed, have been sent out to the property owners asking for renewal.

Right of ways:

The annual notices to property owners to move their vehicles out of the city right of way has begun. This will allow better snow removal and improved vehicle passage way.

Contracts to Vendors for Snow Removal:

The annual contract to our third-party vendors to assist in snow removal in the city have been issued to the local contractors. The rate, which is based on the State of Alaska contract rates, did not increase from last year.

Permafrost Mapping:

The University of Alaska Fairbanks and the Alfred-Wegener-Institute (Germany) are partnering to conduct Permafrost fieldwork next summer in Nome and the region. They will be using LIDAR to measure what is happening to the Permafrost in the region.

I met with the researchers and advised them to reach out to our Tribal Communities, Alaska Native Corporations and the local college staff. As more information becomes available, I will keep you informed.

Indigenous Peoples Day:

This holiday is recognized by the City of Nome and is part of the Union Agreement. All city facilities will be closed that day excluding the Nome Police Station. The Rec Center is being rented out for a private event in the afternoon and evening by NSHC.

The council meeting scheduled for that night will be postponed to Tuesday night, October 10.

City Morgue:

Despite the poor weather this summer, the exterior of the building has finally been power sanded and stained. The next step is putting sealant on it. Over the winter an interior refresh to the building will begin to make it more welcoming for family members to prepare and view loved ones.

Tribal Justice Summit:

Kawerak sponsored a Tribal Justice Summit at the Mini last week for three days. While I was only able to attend for a few hours, it's sad to see our local surrounding communities are facing the same challenges as Nome. One of the issues the summit members recognized was curfews for young people. Other issues included domestic violence, sexual assault, lack of VPSO services, Elder service needs and more.

Delays:

There has been a delay in the planned meeting with our city property assessor to develop the model for the landing tax and anticipated revenue.

There is a delay in proposing amendments in the curfew ordinance. It is more convoluted then I thought and other portions look like they were lifted from a template. For instance, the current ordinance mentions "interstate motor vehicles".
