Mayor Heikkila called the meeting to order at approximately 4:00 PM.

## **AGENDA ITEMS**

1. DISCUSSION REGARDING AN INTERIM APPROPRIATION FOR THE SENIOR WELLNESS CENTER

Anthony Francisco led the discussion. He stated that the Adult Wellness and Education Center is approximately \$1.2 million over budget; however, at one time, the City believed that this cost could be absorbed by the sale of their 718 N. Porter building. The sale of this property is now in question, so alternative sources of funding have been discussed. Parks and Recreation Director Jason Olsen discussed his proposed source of funding. "What the ask is, is that we barrow that \$1.2 million from the General Fund and whenever we do sell that building, we would replace the General Fund money," Olsen said. Councilmember Foreman asked, "What does that do to the General Fund?" Francisco replied, "The General Fund is in a position to absorb it - certainly for a period of months between now and the end of the fiscal year." Councilmember Grant stated that she was "comfortable with the proposal". No formal vote was taken.

2. DISCUSSION REGARDING THE MONTHLY REVENUE AND EXPENDITURES REPORTS.

Anthony Francisco gave the report. October sales tax is flat, but Francisco states this "is a good thing because we're comparing to an up-year." While, the City of Norman continues to lag behind in sales tax compared to its neighboring cities and the state this fiscal year, however, Francisco states that "historically, we're still very high."

Francisco addressed the Water Fund balance. He stated, "What we're finding is that we really need that water rate increase. The Water Fund is not doing well. Our coverage ratios are getting dangerously close to the level that we are contracted with our bond holders to have those coverage ratios. The auditors are probably going to be writing us up about that. The rate increase needs to happen sooner rather than later." Per Councilmember Foreman's request, Kathryn Walker will schedule a study session for Council to discuss a water rate increase. The Forvis auditors will be presenting their unbound, but final audited figures at the next City Council Finance Committee meeting.

## **ADJOURNMENT**

Mayor Heikkila adjourned the meeting at approximately 4:25 PM.
