This is an opportunity for citizens to address City Council. Due to Open Meeting Act regulations, Council is not able to participate in discussion during miscellaneous comments. Remarks should be directed to the Council as a whole and limited to four minutes or less.

Rob Norman - Ward 5

Mr. Norman spoke regarding ongoing opposition to proposed turnpikes. He invited the public, elected officials, City staff, and candidates to attend the annual Pike Off Chili Cookoff. Mr. Norman stated that opposition efforts are ongoing and encouraged continued public engagement.

Gary King - Ward 5

Mr. King requested reconsideration of the December 9, 2025, Western Farmers and OEC meeting, stating that Council was presented with outdated and misleading information. He questioned the routing of infrastructure south of East Norman and raised concerns. Mr. King also expressed concern about how votes were communicated during that meeting and changed project plans, including the removal of a storm retention pond and expansion of the site beyond the originally stated acreage.

Billy Jewell - Ward 5

Mr. Jewell expressed concerns about potential health impacts of living near an electric substation. He questioned whether Councilmembers had researched these issues and stated that decisions affecting nearby residents could have serious consequences.

*

Stephen Ellis - Ward 4

Mr. Ellis recognized workers who remained on duty during the recent winter storm and allowed unhoused individuals to shelter at their workplaces. He emphasized the importance of basic humanity and keeping people safe during severe conditions. Mr. Ellis addressed a parliamentary motion made earlier in the meeting that would have ended public debate and stressed the importance of deliberation and maintaining public comment as part of democratic process.

Paul Wilson - Ward 1

Mr. Wilson raised concerns about traffic congestion related to proposed changes on Gray and Main Streets. He criticized snow and ice removal efforts, stating that plowing could have been more effective.

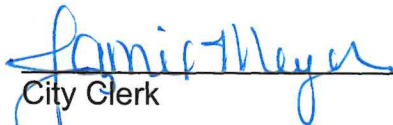
Mayumi Windler - Ward 2

Ms. Windler shared personal observations regarding winter road conditions, noting differences between Norman and states with more robust snow removal equipment. She also highlighted a "Blizzard Buddies" initiative by the Norman Animal Shelter, which encouraged residents to temporarily foster animals during the storm.
