MINUTES

The City Council Special Meeting of the City of Norman, Cleveland County, State of Oklahoma, met in Special Session in the Council Chambers in the Municipal Building, on Tuesday, July 07, 2026 at 6:00 PM, and notice of the agenda of the meeting was posted at the Norman Municipal Building at 201 West Gray and on the City website at least 48 hours prior to the beginning of the meeting.

Comments may be limited on items of higher interest, if so, the Mayor will announce that at the beginning of the meeting. Participants may speak one time only up to 4 minutes per person per item. There will be no yielding of time to another person. Sign up does not guarantee you will get to speak if the allotted time for that item has already been exhausted. If there is time remaining after those registered to speak have spoken, persons not previously signed up may have the opportunity to speak. Comments received must be limited to the motion on the floor only.

Council Farewells

Councilmember Gandesbery thanked all City crews that have worked tirelessly, assisting with storm cleanup. Also noting that neighbors came together to assist one another and exemplified the “Norman Way” through acts of service and community support.

Councilmember Deck reiterated Councilmember Gandesbery’s comments regarding the storm. She also expressed appreciation to Ward 2 residents and the City of Norman, and her family members for their support during the election process, especially recognizing her children and parents for their encouragement.

Councilmember Bruce thanked State and County officials for assisting with storm damage assessments and emergency declaration efforts, as well as City staff and utility crews for their response. He also commended residents, particularly older adults, for their resilience and willingness to help with storm cleanup efforts.

Councilmember Grant welcomed the new Councilmembers and thanked City staff for their storm response efforts. She shared the updated debris collection plan and suggested exploring a community resiliency plan focused on climate-related events and encouraged residents to strengthen neighborhood connections and preparedness.

Councilmember Kirby thanked City and County employees, utility workers, and residents for their hard work following the recent storm and welcomed the two new Councilmembers to Council.

Councilmember Steele thanked Ward 6 residents for their support and civic engagement throughout the election process and committed to maintaining open communication with constituents. He announced that on Saturday July 11, 2026, he would be at Beanstalk Coffee, 867 12th Avenue Northeast, from 11:00 a.m. to 1:00 p.m. and at Hollywood Corners, 4712 N. Porter Avenue, from 8:00 p.m. to 9:30 p.m. to meet with the community to discuss local issues and concerns.

Councilmember Blodgett welcomed Councilmembers Deck and Steele and thanked City staff, Utility crews, and residents for assisting neighbors during the storm recovery efforts and recognized the dedication of linemen and emergency responders.

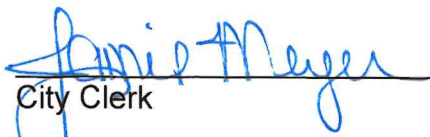
Councilmember Dixon congratulated the newly elected Councilmembers and expressed appreciation to residents who participated in the election process. He also thanked City staff, utility providers, and cleanup crews for their ongoing efforts to remove debris and restore services following the storm.

Mayor Holman welcomed Councilmembers Deck and Steele and reflected on the significant turnover of Council over the past year, noting the challenges of addressing major community issues while serving in largely volunteer roles. He encouraged residents to remain engaged in local government and consider public service opportunities. Mayor Holman also thanked utility workers, City employees, volunteers, and community organizations for their storm recovery efforts, specifically recognizing the Norman High School football team for assisting residents with debris removal. He also encouraged residents to monitor City communication channels for storm recovery updates and promoted upcoming community events, including the Downtown Art Walk and the rescheduled fireworks display at Reaves Park.

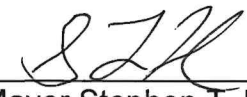
