## COUNCIL ANNOUNCEMENTS

### Ward 1 – Councilmember Gandesbery

Councilmember Gandesbery recognized the Adult Wellness Center for a successful gala and highlighted his visit to Kennedy Elementary as "Legislator of the Day," praising the principal's strong leadership, cultural programming, and the school's improving performance. ## MISCELLANEOUS COMMENTS

Mr. Dan Munson, Ward 7, proposed gradually increasing Council pay to \$1,000 per month and allowing participation in the City's health-care plan. He encouraged Norman to host events during the 2028 Olympics. He opposed new bond proposals and instead supported increasing the Public Safety Sales Tax. He also expressed concern about the Cleveland County Economic Development Coalition's lack of accountability and called for clearer performance requirements.

\*

Ms. Judy Moss, Ward 4, thanked Councilmember Grant for addressing neighborhood concerns and said the meeting provided clarity on issues previously prompting her to support postponement. She emphasized the need for continued impact assessment.

\*

Mr. Stephen Ellis, Ward 4, thanked the Council for approving the Reed Avenue property purchase and praised constructive neighborhood engagement. He suggested offering small safety enhancements like cameras or alarm upgrades. He also criticized the Cleveland County Economic Development Coalition's lack of oversight and suggested ending the partnership.

\*

Mr. Floyd Carroll, Ward 4, requested improved lighting in his neighborhood, noting cameras are ineffective without adequate illumination, and expressed appreciation for the Mayor.

\*

Mr. Joel Raburn, Ward 7, urged the City to condemn the recent detainment of Dr. Vahed Abadini by ICE and asked that NPD decline to assist ICE. He stressed the importance of protecting immigrants and international students.

\*

Ms. Jeanette Coker, Ward 4, supported high-barrier housing models near neighborhoods and cited Oxford Houses as successful examples. She asked the City to avoid placing individuals who may pose safety risks and expressed concern about low-barrier approaches.

\*

Mr. Michael Carter, Ward 4, opposed the proposed SPUD rezoning on Chautauqua, citing zoning violations, inadequate parking, over-coverage, runoff issues, lack of setbacks, and incompatibility with the campus neighborhood. He warned that high-density development could erode longstanding neighborhood character.

\*

Ms. Barbara O'Brien, Ward 4, expressed concern about heavy traffic near her home and frequent accidents at Hoover/Chautauqua. She said the proposed 24-unit development would worsen congestion and harm the neighborhood's character and asked the Council to oppose the rezoning.

\*

Miscellaneous Comments, continued:

Ms. Cindy Rogers, Ward 4, outlined existing City investments that support economic development, including water systems, schools, transportation, public safety, and Norman Forward amenities. She cautioned that growth imposes long-term costs not fully covered by new revenues, shifting burdens to residents, and urged the review of the upcoming Raftelis Report.

\*

Ms. Mayumi Windler, Ward 2, requested regular outcome data for homelessness services, similar to intake/outcome reporting in animal welfare. She also asked for transparency regarding spending and impacts related to the Cleveland County Economic Development Coalition.

\*

Ms. Maggie Coffman, Ward 4, opposed the proposed 24-unit development on Chautauqua, saying it would significantly increase density, traffic, trash, and noise and alter the neighborhood's character. She objected to a "no parking" designation on Hoover and urged a "no" vote.

\*

Mr. Michael Gladson, Ward 4, advocated more mental-health professionals rather than increased police presence to address neighborhood concerns and described personal experiences with profiling while walking.

\*


Mr. Joe Grzybowski, Ward 4, opposed the three-story development near his home, citing privacy concerns, neighborhood encroachment, insufficient space for refuse management, and worsening of existing rodent and traffic issues.
