<u>OU Motel</u>. Mr. Paul Wilson, Ward 1, said it had upset him that a few weeks ago Council approved rezoning a plot of land near the OU Motel. He said staff announced that night that there were no protests. He said he is an Uber Driver and he picked up a resident from the OU Motel the day after the meeting and the resident knew nothing about the rezoning. He said there are many people, including children, who call the OU Motel their home. He said when this building is demolished, they will have nowhere to go. He said Norman already has problems with the homeless population and if this happens, there will more people out on the street. He said these people do not know when the building is being demolished.

Ms. Crimson King, Ward 7, said her family lives at OU Motel. She said she is a mom. She said her sister works at OU Motel and knew nothing about the building being demolished. She said not only will this action take peoples' jobs, but it will also take away her family. She said OU Motel was her last resort for housing. She said she has nowhere else to go and she has 9 children. She said without this home, the State will take away her kids. She said the State places children with her. She asked to please not take her home away. She said OU Motel has bad people in it, so they don't leave their apartment.

Mr. John High, Ward 7, said the City should evacuate those people so they can be safe. He said he thought everyone was notified when something like this is going to happen.

He said what if there was an application process where someone could submit a proposal for a presentation that would be good for the public.
