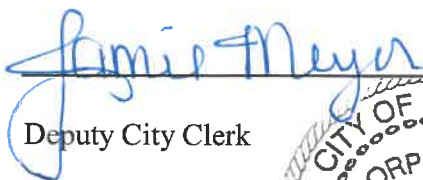
Inclusivity
