MISCELLANEOUS COMMENTS

Permanent Supportive Housing on Triad Village Drive

John Scamehorn, Ward 1, introduced himself as a retired chemical engineer and 44-year resident of Ward 1. He expressed appreciation to Councilmember David Gandesbery for pulling the item off the consent agenda. He voiced strong opposition to permanent supportive housing projects, particularly the proposed development on Triad Village Drive. His concerns included proximity of units to senior housing and a children's playground; negative impacts observed from similar facilities, such as "Friend's House" in Ward 4; potential safety concerns for seniors, including fears of panhandling; and decline in quality of life and property value for Ward 1 residents. He felt this project is part of a larger plan to expand permanent supportive housing across Norman and criticized the City's prioritization of the needs of the chronically homeless over the "honest, hardworking citizens" of Norman. He called for the Council to refocus on initiatives beneficial to senior citizens and working-class neighborhoods.

Permanent Supportive Housing on Triad Village Drive, continued

Mayumi Windler, Ward 2, inquired about zoning for Greek houses, questioning whether such zoning could accommodate supportive housing models.

Council Annual Retreat

Dan Munson, Ward 7, recommended that the Council discuss implementing an entertainment tax for the UNP (University North Park) during the upcoming Council retreat. He suggested the tax could fund a 230-foot aerial lift fire truck to support high-rise developments such as Embassy Suites and the arena.

*

Oklahoma Highway Patrol

Dan Munson, Ward 7, expressed concern over the Oklahoma Highway Patrol ceasing patrol of I-35 in November, requiring additional local police for traffic enforcement.

*

University North Park (UNP)

Dan Munson, Ward 7, commended the Parks and Recreation team for excellent maintenance at Legacy Park and criticized the rest of the UNP area for poor infrastructure and landscaping, including potholes, dead trees, and unsafe drainage ditches. He recommended an ordinance to hold property owners accountable for maintaining standards equivalent to Legacy Park.

*

Racism Stinks

Richard Baxter, Founder, Racism Stinks, introduced himself and noted disappointment over missing the recent swearing-in ceremony due to lack of notice. He expressed eagerness to work with the new council and commended them for their dedication to public service.

*

Aquatic Rodents

Mayumi Windler, Ward 2, commented on Item 18 regarding the relocation of aquatic rodents; questioned where the animals are relocated and highlighted potential stormwater issues. She raised concerns about flood risk in Norman, citing firsthand experiences at Lion's Park during rainstorms and asked what preparations the City has in place for flood warnings and response.

Texas Flooding

Mary Katherine Long, Ward 1, expressed appreciation for the Norman Fire Department's assistance in Texas during recent flooding.

Miscellaneous Comments, continued

Public Transit

Mary Katherine Long, Ward 1, thanked the City for its public transit system, specifically citing her reliance on buses after a vehicle breakdown. She praised bus routes 24, 111, and 112, and issued a light-hearted challenge for Councilmembers to ride the bus with her. She commended City staff, especially Taylor Johnson, Transit and Parking Program Manager, for responsiveness to transit-related concerns and highlighted the importance of public workers who improve everyday life.

Health-Conscious Lifestyle

Evan Dunn, Ward 7, advocated for health-conscious lifestyle changes, including better nutrition and reduced use of plastics. He promoted the local farmer's market and recommended using biodegradable products like bamboo toothbrushes. He also shared details about completing a three-day fast, promoting bone broth as a healthy transition back to eating and encouraged others to read the book *Breath* and emphasized the role of oxygen and metabolism in weight loss.

Small Business Administration (SBA) Funding

Maryann Bradfield, Ward 3, SBA Public Information Officer, announced that the deadline to apply for disaster assistance for wildfires and straight-line winds is in two weeks. She explained that the SBA offers low-interest loans up to \$500,000 for homeowners and \$100,000 for renters. She said loans can include damaged vehicles, even when insurance is insufficient. She urged residents to apply early even if unsure they need assistance, and emphasized there are no fees, obligations, or penalties associated with applying. She provided information about working with FEMA and shared materials with City staff.
