She would like to see that people in situations like that not be automatically taken to jail, but have some other form of policy in place to keep that from happening again.

Ms. Karlinda Gravel, Ward 4 spoke about confronting a homeless intruder in her backyard on February 26, 2023, and not feeling safe in her neighborhood.

Chelsea Gravel, Ward 4, speaks about not feeling safe in her neighborhood and has had several frightening encounters with homeless men.

Diane Wheeler, Ward 8, read a letter from a local business owner that wanted to remain anonymous about how a homeless man that was aggressive has begun harassing her inside of her business and is asking Council to make Norman safe again.
