Committee members agreed that they wanted to interview all applicants. Those being interviewed include James Howard, Heather Hall, Robert Bruce, Rendon Chambers and James Beaty. The meeting for interviews with the candidates will be scheduled for Monday, October 20, 2025, beginning at 4:00 p.m. Candidates will be scheduled in 30 minute intervals. The Deputy City Clerk will schedule them by lot and notify each candidate of their respective time. At the conclusion of the interviews the Committee will discuss which applicant to move forward for Council consideration.
