- Reported attending the Norman High School girls' basketball game at the Oklahoma City Arena. Noted the team's comeback victory over Tulsa Union, highlighted standout performances by Halen Browning and Key Parks, and congratulated the Norman High Lady Tigers on advancing in the state tournament.

Ward 7 – Councilmember Holman

- Thanked Principal Hallie Wright for inviting him to the Norman High Career Job Fair, commended the wide variety of career booths, and expressed appreciation for the City of Norman's participation.
- Provided an update on the Jenkins Avenue Widening Project, a \$15.5 million voter-approved initiative with over \$10 million in federal funding. Construction began last week, is expected to last up to two years, and will keep two lanes open at all times to minimize disruption.

MISCELLANEOUS COMMENTS

Water Treatment Discharge

Jared Miller, Ward 5, reported chlorine discharge from the Robinson Water Treatment Facility into Rock Creek. He noted tens of thousands of fish were killed, with six miles of Rock Creek affected and impacts reaching Little River and Lake Thunderbird. He opposed the proposed new water treatment plant, citing risks to his recently purchased pond due to upstream discharge.

Use of Chloramine in City Water

Ben Plummer, Ward 4, raised concerns about the City's use of chloramine instead of chlorine. He explained chloramine lingers longer than chlorine, making removal difficult and creating challenges for gardeners and agriculture. He noted many local farmers and gardeners avoid full reliance on City water because of plant damage.

Community Unity and Public Safety

Richard Baxter introduced himself as founder of the nonprofit Racism Stinks and an OU student. He announced the Norman Cultural Unity Parade and Healing Exchange campaign on May 3rd and emphasized themes of unity, rebuilding trust in law enforcement, and broad participation. He requested Council support, encouraged \$5 donations, and thanked local leaders for their assistance.

Turnpike Authority South Extension

Kelly Wilson, Ward 6, reported that the Turnpike Authority announced it would restart work on the South Extension after denial of the current route. She recommended that Council request inclusion on all communications from the design team and suggested the City host its own public meetings to ensure meaningful feedback and citizen engagement, citing past Turnpike Authority meetings as unresponsive.

Farmers Market and Environmental Awareness

Evan Dunn, Ward 7, announced the Farmers Market will take place on Saturday. He spoke on environmental and health concerns, including water chlorination, exposed soil, and conscious choices about food and chemical intake. He urged community resilience, creativity, and empowerment through environmental and dietary awareness.

Acknowledgements and Personal Reflections


