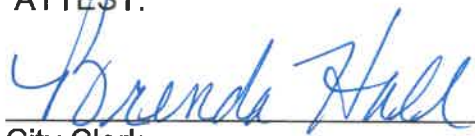
Stephen Ellis, Ward 4, thanked Council, the City Manager, and David Grizzle for the Citizen's Corps presentation.

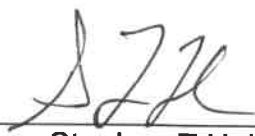
