MISCELLANEOUS COMMENTS

This is an opportunity for citizens to address City Council. Due to Open Meeting Act regulations, Council is not able to participate in discussion during miscellaneous comments. Remarks should be directed to the Council as a whole and limited to four minutes or less.

Trey Kirby - Ward 5

Mr. Kirby raised concerns about herbicide use and the risk of “forever chemicals” contaminating the watershed feeding Lake Thunderbird. He cited national PFAS issues, noted a lack of transparency about which chemicals would be used, and urged the Council to avoid NDAs, ensure greater oversight, and prioritize long-term environmental protection.

*

Andrew Rosenow - Ward 6

Mr. Rosenow opposed Flock AI cameras, citing wrongful detentions, privacy risks, potential misuse, and weak data security. He encouraged the Council to reject both public and private use of AI license-plate readers and to strengthen privacy protections.

*

Mayumi Windler - Ward 2

Ms. Windler commented on the City's financial reports, noting that sales tax and General Fund revenues came in below budget, though expenditures were also under budget. She thanked staff for clearly presenting permit and licensing data.

*

Miscellaneous comments, continued:

Ms. Cynthia Rogers - Ward 4

Ms. Rogers discussed the City's economic development incentives policy, arguing it needs modernization, broader representation on the advisory board, and clearer, more meaningful criteria. She cautioned against relying on retail sales tax growth as evidence of true economic impact and emphasized that many incentives simply shift spending rather than generate new revenue.

*

Luigi Polvani – Ward 4

Mr. Polvani opposed public subsidies and urged caution on initiatives like the OTA and TIF. He supported mixed-use redevelopment at Griffin, higher short-term rental fees, removing Rule 3, and raised concerns about police response and Flock camera privacy.

*

Ms. Diana Hutzel - Ward 5

Ms. Hutzel thanked the City for the parade and noted that Norman's revenue growth significantly trails nearby cities. She highlighted declining per-resident spending and lost economic opportunities and urged the Council to focus on infill and redevelopment rather than expanding into Ward 5.


Audrey Day - Ward 1

Ms. Day opposed using public funds to incentivize large national retailers, arguing that it harms small businesses and causes more money to leave the local economy. She also opposed Flock cameras and similar technologies, warning that they create new avenues for surveillance that private companies cannot currently replicate without such systems.
