DISCUSSION OF SPRAYING PROGRAMS IN NORMAN

The questionnaires were handed out for Streets and Stormwater. They are still waiting on OU and may or may not get the public school one. Cretsinger asked about the roundup statement that it is still in inventory and used sparingly and she was concerned that just because it is in inventory they are going to use it up. Bondy stated that she did a little research and that she has always been super anti roundup and based on her research she isn't finding that it is very harmful and wants someone to disprove that. Croft said that she also looked it up because you hear all the lawsuits about it causing cancer and stuff but all the data that places have collected have shown that there really isn't any evidence to support that. Croft pulled up the document that was sent out previously and no one received it so she said she would send it out. It was asked, when it is used sparingly, what is its application. Murphy said that he cannot answer that question right now. He knows what Stormwater is using but he hasn't seen anybody use it at all. Baranowski asked what distance they were looking at approximately. Murphy said that he didn't want to throw a number out, that Chao knows the number off hand but that he does not. He also asked how they determine when additional applications are needed. Murphy said that it is typically near bridges. If they see things growing really thick near bridges then they will do inspections to determine if it is needed.
