MISCELLANEOUS COMMENTS

<u>Eagle Cliff Addition</u>. Ms. Allyson Wilson, Ward 4, thanked Council for listening to citizen's concerns regarding this item and voting no.

Ms. Sonja Potts, Ward 3, thanked Council for voting against the Eagle Cliff Addition item. She said several Councilmembers visited the area to see the erosion and stormwater problems she and other abutting property owners are concerned about and thanked the Councilmembers for taking time to do that.

Mr. Kevin Potts, Ward 3, thanked Council as well. He knows it was not an easy decision for Council, but felt this could be an opportunity for all involved on this item to work together for the greater good of the community. He said the Potts land is extremely important to him and it is important to be able to use the land for the purpose of agriculture without worrying about stormwater runoff inhibiting his ability to farm his land. He said some of the farmland has already been lost forever due to stormwater drainage issues from existing development in Eagle Cliff.

Mr. David Burget, Ward 4, thanked Council for listening to concerns tonight about this item.

Miscellaneous Comments, continued:

<u>Eagle Cliff Addition, continued.</u> Mr. Derek Rosendahl, Ward 7, also thanked Council for their courage to say no to this item. He said he has spent over 200 hours documenting and taking pictures of the erosion problems in Eagle Cliff Addition. He appreciates Council taking these concerns seriously and doing the right thing, but is concerned that the Staff report makes it seem like there is nothing wrong, but there are legitimate problems with erosion and new development will only make a bad situation worse. He said that is something that has to change because if he and others had stopped protesting after the Planning Commission recommended denial, he is afraid Council would never have known that there are very serious issues with stormwater and would have approved the agenda items for Eagle Cliff Addition based on information in the Staff report.

Ms. Cynthia Rogers said Staff reports are usually about trying to find a way to say yes to development and she is proud that tonight the City evolved to find a way to say "should the City say yes." She said finding a reason to say yes is much easier than asking if Council "should" say yes. She agreed Staff reports are misleading and should include pros and cons of a development. She said just because Council has approved contentious items in the past does not mean they have to continue doing that.

<u>Electricity</u>: Mr. Dan Munson said electricity costs are getting ready to greatly increase due to the recent winter storm and asked if the City is budgeting for that increase.
