MINUTES

 APPROVAL OF THE MINUTES FOR THE SEPTEMBER 22, 2025, REGULAR MEETING

3. DISCUSSION AND POSSIBLE ACTION REGARDING HRC MEETING CALENDAR FOR 2026

Commissioners reviewed the draft meeting calendar for the year 2026 showing meetings on the 4th Monday of every month at 5:30 pm. Commissioners agreed to have no meeting for January and December, and to move May's meeting from the 25th to the 18th due to the holiday.
