## UPDATE ON THE CITY OF NORMAN TREE STORY AND ART CONTEST

Chair Menzie received approximately 40 applications, dropped them off with Staff so they could scan and email them to the Tree Board. Attending Board Members decided to extend the contest through March, 10, 2025. Chair Menzie said he will bring any new applications to Staff to be scanned and emailed to the Tree Board. The Board will vote on the winners during the April 7, 2025 meeting so they can be recognized at Earth Day.

## MISCELLANEOUS DISCUSSION

Colin Zink, City Forester, stated there is nothing new to update regarding the Tree Inventory Project and the proposal for the new Tree Ordinance is still under review by City Council.

Regarding the Community Wildfire Protection Plan, Mr. Zink met with Choleta and stated that he is plugging in vegetative types now, and will then enter them into a Weather and Climate model. Data will also be entered into a Fire Behavioral Model to determine high priority areas, and once identified, will be overlaid with GIS Maps to determine if various structures are located in the high priority areas. Mr. Zink continued by stating once the Community Wildfire Protection Plan is completed, the City will be able to apply for grants towards identifying priority areas and projects.

Member Barksdale stated that Staff should remind the Steering Committee that prescribed burns is a great tool to mitigate fires.
