Background: In January, the city of Norman invited Strong Towns, a national nonprofit concerned with building resilience and prosperity in North American cities, to support the commission in hosting a 24-month program consisting of in-depth community conversations, leadership training and resource expansion. This program will shift the conversation about development in Norman.

Community Action Lab Content: As Strong Towns has engaged with the Strong Towns AD HOC Committee and the public, the feedback we have received is simple: "We want more of this. The Strong Towns message is critically important to us and we want to go deeper to really understand how it applies to our community. We want to be more involved."

In response, Strong Towns has taken the course materials and learning path that were prepared for the Norman Action Team and reworked them for the general public.
