MINUTES

The proclamation for Mental Health Awareness Month has been moved to May and Chair Ali said she would send proposed language for the Cultural Diversity proclamation to Ms. Encinias.

Commissioners reviewed the annotated and clean versions of the amendments regarding the nomination criteria. The changes were accepted by unanimous vote.
