OPERATOR UPDATE

Ms. Claire Dowers-Nichols, Healthy Living, distributed a handout and highlighted the hiring activity. She introduced Katherine Leidy, (Branch Manager), and Ginna Dowling, (Art Coordinator), and each of them gave a small summary of themselves, to include their experience and education. Ms. Dowers-Nichols said the Office Manager position has been posted and interviews for a Program Manager and Facilities Coordinator are currently being conducted. She said the Front Desk position will be posted next week and coversations regarding facility instructors are in progress.

Ms. Dowers-Nichols said membership fees were discussed at the last meeting and reminded them that individuals are \$35 per month; married couples are \$60 per month; there will not be any enrollment fees and/or signed contracts and month-to-month memberships will be available. She said Renew Active (United Healthcare/Optum) have confirmed they will except AWE memberships on their insurance plan and she has reached out to Silver Sneakers, but they have not yet responded. Ms. Dowers-Nichols said there will be a sliding scale based on Federal Poverty Guidelines stating a local group is raising funds to assist those in need.

Ms. Dowers-Nichols said a website for the AWE is in development and should be up and running next week. She said BOLD Media is now managing the Healthy Living Norman Facebook page stating specific email addresses and phone numbers will be published in the coming weeks and brochures are currently being printed.

Ms. Dowers-Nichols highlighted fundraising opportunities discussed at the July, 2023 meeting to include corporate sponsors (community sponsors), scholarship funds and founding members (three-year membership paid upfront for \$1,000). She said founding members will be acknowledged on a donor wall at the AWE; will receive invitations to the VIP Opening event, as well as invitations to other special VIP events.
