#### Notes:

In August 2024, one guest moved into Food and Shelter housing using support through Food and Shelter funds. Due to the end of grants and lack of vouchers, we are having a difficult time getting people housed outside of shelter.

#### According to data in HMIS:

29 of our 103 guests reported having a physical disability. 12 report having a chronic health condition.

Since we have been specifically documenting turn-aways, we continue to average 10 people per night or higher requesting shelter but having not enough space. Important to note, this does not include those who cannot attempt to have a shelter bed due to animals in their care.
