UPDATE OF PROGRESS ON MASTERPLAN ITEMS FROM PREVIOUS MEETING

- This was the first meeting of this subcommittee, no updates are included.

CRITICAL DISCUSSION ITEMS FOR MASTERPLAN UPDATE ITEMS

This is the first meeting for the Transportation sub-committee. Bret Cabbiness is the lead for the consultant and presents their presentation. The presentation outlines the process for developing the Transportation portion of the AIM Norman Comprehensive Plan. The first task is developing the baseline of the plan and is the main focus of this first meeting. The baseline will be established by the available supporting documents: ACOG's Encompass 2045 Plan; ODOT's 8 Year Construction Plan; City of Norman's 2014 Comprehensive Transportation Plan; City of Norman's Go Norman Transit Plan; Max Westheimer's Plan; City of Norman 2025 Land Use Plan; and RTA of Central Oklahoma Transit Plan. Garver will provide copies of the presentation as well as the supporting documents with links in e-mails or hard copies as requested.

- TRAFFIC

- Garver presents the existing roadway classifications. Teresa Elam asks how the classifications are determined. Bret Cabbiness explains that there are several factors such as traffic volume, speed, roadway width, and design standards that are included in the classification determination.
- Teresa Elam asks how we are designing traffic flow. Brett Cabbiness explains that it depends on the priority of this sub-committee, access management, future developments, and mobility.
- Mike Spayd and Ashley Maggio with Garver presents the traffic portion of the presentation. Garver presents ACOG's traffic model for congestion within the City of Norman and the growth model based on traffic volume for the last 10 years.
- Safety is presented next with the top 20 intersections with the most collisions from 2016 to 2021, the collision rates based on volume, and the crash trends/type of collisions. Trey Bates asks why 36th Avenue NW and Franklin Road were not included. Garver is open to looking further into collisions and specific intersections if requested from the sub-committee members. Chuck Thompson discussed interest in looking at access management along Lindsey Street from I-35 to Berry Road.

- ROADWAY AND BRIDGES

- Garver presented the 2019 Transportation Bond Slide and there are 5 bonded projects and 14 federally funded projects. There is a discussion among the sub-committee members around the project at 36th Avenue NW from Tecumseh Road to Franklin Road and how it was bonded in 2012 and it is still not completed. City staff explains the reasons why it was initially added and how the changes with ACOG's federal funding criteria affected the progress of this project.
- Garver presents the Bridge Maintenance Bond 2023 and explains that it covers 20 of the 75 total bridges within the city limits.
- ODOT has started a study for State Highway 9 from 24th Avenue SE to Interstate 35 (I-35). ODOT also has a study for I-35 from Main Street in Norman

to the middle of Moore. Attempts will be made to make these studies available however based on previous attempts, it isn't likely ODOT will release this information until it is finalized.

- SIDEWALKS, TRAILS AND BIKE LANES (ACTIVE TRANSPORTATION)

- Marty Shukert with RDG presented the bike and pedestrian portion of the presentation.

The time was 3:00pm at this point in the presentation. A couple of the sub-committee members (Trey Bates and Lance Lamkin) had to leave, the rest stayed for the remaining portion of the presentation.

- PARKING AND TRANSIT

- Slides were presented based on the Go Norman Transit document.
- Taylor Johnson explained that the recommended bus routes on their slide were now the current bus routes being used as of October 16, 2023.

- AVIATION

- Max Westheimer Master Plan was recently sent to the Federal Aviation Administration and is under review. It mainly discusses items within the airport property.

SUB-COMMITTEE HOMEWORK

- Sub-committee members were asked to familiarize themselves with the supporting documents, especially the City of Norman's 2014 Comprehensive Transportation Plan (CTP) and the 2025 Land Use Plan.
- Members were asked to brainstorm ideas on needed updates for the plan keeping in mind the guiding principles established in the 2014 CTP.
- Bret Cabiness handed out hard copies of the 2014 CTP to the sub-committee members.

CLOSING COMMENTS

- Chair Jim Adair thanked the subcommittee members for their participation and time to be there for the meeting.
