- Amanda Nairn asked for a clear indication of which financials are updated estimates with consideration to the inflation costs.
- The committee discussed updating the plan to have a connection with goals to the development principles.
- Amanda Nairn brought attention to wording that is being repeated within separate sections of the plan and needs to be addressed and revised.
- Rachel Butler requested a revision to be made for the wording on goals 2, 3, and 5.

4.3. Vote of approval, acceptance, rejection, amendment, and/or postponement of recommendation of Stormwater Master Plan Update Report to AIM Norman Steering Committee

- Vote was postponed at the request of the committee due to the number of members absent.
