Heather Supinie gave a brief summary of the Water Quality Protection Zone (WQPZ) Ordinances and recommendations put together with Russell Dutnell (absent). Committee discussed WQPZ Ordinances and ways to incorporate into the Land Use Plan.

Amanda Nairn informed the committee Shellie Chard and Tassie Hirschfeld will give a presentation on TMDL/MS4 Requirements at the next meeting on September 3.

Amanda Nairn and Andy Sherrer discussed Cities Incentivizing LID and examples that could be applied to Norman.
