



Municipal Code 24-501: Interference with Property's Use

No person shall detrimentally use another's property or wrongfully interfere with the use of any public or private property by the owner or the person entitled to its use

Proposed Plan for Walmart Carts

NPD will make contact for citations

Once cited, cart will be seized and returned to store

Propose 3 options for cited individual belongings:

- 1. Abandon items (signing an affidavit of non-ownership) and items will be disposed of
- Request items be booked into Property Custody as found property
 - Items will be collected and a "receipt" with a case # and the contact/hours of operation for retrieval will be provided
- 3. Move items into a bag or other vessel and individual may retain their belonging




AFFIDAVIT OF NON-OWNERSHIP
