SUBJECT: CANVASSING MUNICIPAL ELECTION RESULTS
DATE: NOVEMBER 14, 2024

Following the Tuesday, November 5th, 2024 General Election, the City Council is required to meet as the canvassing board for the municipal election and declare the results. The City Council established this meeting to occur at 9:00am on Friday, November 15th.

This year the canvassing is for the Mayor’s seat and two City Council seats. A resolution is attached to formally canvass the results.

Some notes about the election results in New Prague:

Voters Registered at 7AM:	5,339 (versus 5,164 in 2022)
Votes Cast at Polls	3,496 (versus 3,232 in 2022)
Persons Registered on Election Day	439 (versus 196 in 2022)
Number of Accepted Absentee Ballots	1,380 (versus 523 in 2022)
Total Number of Persons Voting	4,876 (versus 3,755 in 2022)
