The Canvassing Board met to canvass the challenged ballots of the June 13, 2023 Municipal Election and to do a recount of the votes on amendments from a selected ward.

Ward II was randomly selected by Chief Mike Whisman for a recount of the votes on the amendments of Charters #6, #7, #8, #9, #10, #10(a), #11, #12, #14, #16, #19, #20, #22 and #30.

The City received five provisional ballots. Two from Ward II, and three from Ward I. City Clerk Ronda Falk requested the two from Ward II be counted as they were registered voters of our county and they affirmed the change with signatures on poll ticket and had no other challenges. Motion was made by Council Member Janney to accept recommendation, seconded by Council Member Jackson. Motion approved 4-0

City Clerk Ronda Falk requested one of the three provisional in Ward I be counted because the individual was in the poll book and a registered voter in our county. A motion was made by Council Member Smallwood, seconded by Council Member Jackson to accept recommendation. Motion approved 4-0.

It was requested by the City Clerk that the other two provisionals in Ward I not be counted because they had two challenges: they were not in the poll books and the individuals were unable to provide proof of ID. The best practice guide for canvass from the WV Municipal Election Training manual from February 15, 2023 was used. A motion was made by Council Member Jackson to accept recommendation, seconded by Council Member Hodges. Motion approved 4-0.

A motion was made by Council Member Janney to adjourn at 10:20 p.m. and to reconvene at 5:30 p.m., Thursday, June 22, 2023 for the recount. Seconded by Council Member Jackson. Motion approved 4-0.
