# **Citizens Comments**

<u>Christa Hodges</u> invited everyone to attend Destination Downtown's meeting on January 15, 2020 at the Lewis House on Main St.

<u>Shelby Underwood</u> questioned why the water had a foul odor. She was directed to contact the West Virginia American Water Co. (2) She expressed concern about a rumor that the City was planning to annex Terry Ave. The City Manager assured her there has been no discussion or plans to annex the area. (3) She raised objections to the Oak Hill City Police responding to calls outside their jurisdiction. (4) There was a short discussion with Fire Chief Richardson in relation to violations of the Fayette County Enforcement Code.

<u>Jerry McCracken</u> announced he was speaking on behalf of Linda Johnson; she received a Notice to demolish the structure at 250 Minden Rd. There was an extensive discussion on the Ordinances for unsafe structures, Council's procedures, and the property owner's responsibilities.

- City Wide Clean-Up. The City Manager asked for Council's help in spreading the word in getting the community involved. It was suggested to request the Beautification Committee consider a clean-up project in the Spring.
- Farmer's Market usage and plans for the future.
- Mud-hole on Maple Ave. with the associated sidewalk being overgrown with grass.
- Boarding up doors of abandoned houses.

# **Mayoral Comments**

The Mayor commented on the success of the Christmas Parade in spite of the weather; he thanked the City staff for their willingness to work in the inclement weather. (2) He informed Council members he had participated in a WQAZ Commercial urging people to buy locally. (3) He expressed he would like to have each Council Member provide a short biography, photograph, and contact information for the oakhillwv.gov website. (3) He suggested Chief Whisman publicize the Crime Rate statistics that reveals the significant drop in crime.

2. Demolition bid opening for 204 Third Ave., map 12, parcel 63 owned by Suzan Blevins The City Manager reported three contractors attended the Mandatory Pre-Bid Conference and received one sealed bid. A proposal of \$4,800.00 from Empire Salvage was reviewed and found to be in order.

3. Structural Inspection Board recommendation order to demolish 215 Mayfair Ave., Map 32, Parcel 162 owned by Betty Adkins & Raydmond Jones

The City Manager informed Council the owners were properly served and aware of the SIB's recommendation.

The members were informed the property's location is across from the Waste Water Treatment Plant in the community of Minden. The demolition was more expensive due to the location and the contractor having to go through an adjoining property.

Planning Commission Chairperson Steve Moss explained the reasoning behind the request to repeal (with a replacement) and amend the Municipal Codes.

The Little Caesars Director of Operations addressed Council with plans to remodel the building inside and out. Their plans are to expand the parking lot to allow more parking; the drive-thru will be redirected around the building in order to stop backup on Main St.

As part of the observance, he encouraged the City of Oak Hill to promote appropriate ceremonies and programs; appoint a Celebration Committee to plan, develop, and carry out all events. He acknowledged the role and achievements of the inspirational James Monroe Ellis.
