This property has been sold to Dewayne Hopkins. The City Manager and City Attorney recommend tabling the item until April.

Councilmember Oxley explained the location chosen for the Veterans Memorial site will be the lot on the corner of Maple Ave and Main Street, adjacent to Davis Tire and Muffler. This property is owned by the Jones Family.

**7. Consideration of One-way Parking on Assigned Streets**

The City Manager explained that he and the Public Works Director have assessed several streets to consider one way parking. He foresees this to be an ongoing project and he will be seeking participation from the residents of the affected streets.

Council member Perry mentioned that he had asked the City Manager to look into this problem and had developed a list of streets that needed attention. The streets are Thompson Avenue, Washington Avenue between School Street and Park Street, the bottom of Mayfair, Chestnut Street between Park and Richards Street, the alley behind the Pawn Shop, Lee Street, and Rhodes Street.

If the City Manager's approach does not work, he would like to see more aggressive action taken.

**8. Approval for Mold Assessment of the Former BB&T Building and New City Hall**

Councilmember Perry received estimates from three mold assessing/remediation companies for the purpose of inspecting the former BB&T building for mold. The price ranges from \$300 to \$2,200.

**Motion - *Approve the payment of a mold assessment for the former BB&T building.***

**9. Consideration to Modify Municipal License Fee - 1st Reading**

The City Clerk-Treasurer explained that this amendment to OHMC 4.02.70 will change all license fees to \$15.00 except for contractors, handyman, and alcohol license. The amendment to OHMC 4.08.150 will remove the B&O Tax exemption for rental properties.

**Motion - *Accept this as the 1st reading of the amendments to the municipal code as explained by the City Clerk-Treasurer.***

**10. Consideration to Redistrict the City Within Six Months of the Release of the Census by the United States**

The City Manager explained that the population change was not significant enough to redistrict our voting precincts.

- A. Virginia Street Sidewalks**
- B. Oak Hill Fire Dept. Addition**
- C. Oak Hill City Park**

The City Manager reported the selection committee for the Virginia Street Sidewalks, the selection committee for the Oak Hill Fire Department Addition, and the selection committee for the Oak Hill City Park each recommends the selection of The Thrasher Group as the consulting firm for the individual projects.

**Motion - *Approve The Thrasher Group as the consulting firm for all projects discussed.***

Council member Perry commended the City Manager on a job well done in organizing the process of selecting a consulting firm for these projects.

Jonathan Carpenter, Regional Manager for the Thrasher Group, gave an overview of each project.

**13. Approval to Participate in the HubCAP (Communities of Achievement Program)**

A representative with the WV Community Development Hub explained the Hubcap Program and how it could benefit the City of Oak Hill. The Community Development Hub is applying for USDA funds for the Hubcap program and a participation of \$2,500 would be required from us.

**Motion - *Authorize participating in the Hubcap program and provide \$2,500 as our participation.***

Data from speed signs; status of LED street lights; news releases; Councilmember Perry was erroneously listed in the code enforcement report as making a complaint.

The Mayor asked Council for comments and the following was mentioned:

Jeffries Family; drainage along Virginia Street; Minden Park; James Ellis marker; playgrounds being ADA compliant and accessible; lights at Harlem Heights, Catholic Center fish dinner, increase presence on Allman Street when school lets out; public meeting date for ARPA funds, criticism concerning demolition of scout cabin; agenda in the newspaper; prioritize parks, and the opportunity for the city park to be a premier attraction.
