ADDENDUM IV

THIS ADDENDUM, made MAY 21, 2018, is hereby made an integral part of Contract of Lease No. CHH-006-418, which Contract of Lease was made MAY 6, 2011, and amended via addenda thereto, by and between CITY OF OAKHILL, a Public Authority, as Lessor, and the STATE OF WEST VIRGINIA, by the DEPARTMENT OF ADMINISTRATION, REAL ESTATE DIVISION, as Lessee, for and on behalf of the NATIONAL COAL HERITAGE AUTHORITY, FORMERLY KNOWN AS COAL HERITAGE HIGHWAY AUTHORITY as Tenant.

WHEREAS, the Lessor has leased unto the Lessee, for use by the Tenant, the following described Premises:

Office space consisting of approximately 1,800 square feet, more or less, and approximately 500 square feet, more or less of storage space for a total of 2,300 square feet, more or less, and identified as rooms 1, 2, 3,4, 5 and 6 on the second floor of the 2-story brick building, commonly known as the Municipal Building located at, 100 Kelly Avenue, in the City of Oak Hill, Fayette County, West Virginia, along with six parking spaces. (hereinafter referred to as the "Premises").

WHEREAS, both parties hereto agree to extend the term of said Contract of Lease for one additional TWO-YEAR period beginning MAY 1, 2018, and ending at midnight on APRIL 30, 2020 at the current annual per square foot rate of \$12.00

WHEREAS, both parties hereto agree that the above-stated changes shall be effective MAY 1, 2018.

NOW, THEREFORE, THIS ADDENDUM WITNESSETH:

It is agreed by and between the parties hereto that certain sections of the subject Contract of Lease are amended as follows:

(A) Page 1, Item 1, entitled "TERM AND NOTICES", first paragraph shall be amended to read as follows:

The term of this Contract of Lease, subject to the provisions hereof, shall begin on MAY 1, 2018, and end at midnight on APRIL 30, 2020. The Contract of Lease shall be considered renewed for each ensuing fiscal year during the term of the Contract of Lease unless it is canceled by the Lessee before the end of the then current fiscal year.

(B) Other Terms and Conditions:

The subject Contract of Lease shall now be identified as CHH-006-420 to reflect the new expiration date. All other terms and conditions shall remain in full force and effect.
