Cody Oakes:

Cantrell asked Oakes about his numbers with his youth programs. Oakes stated that he has 67 in baseball and 80 kids K-1 in blast ball and t-ball teams, charging \$25. Oakes stated that there are 18 kids on the travel team grades 3-6 that he charges \$75 per participant and he has nothing for 7 & 8th grade since the school has teams. Discussion on using volunteer umps as Oakes stated he pays umps \$50 a game. Oakes stated that he is using what diamonds he can but disapproves of city diamonds and soccer fields. Oakes talked about the remaining scheduled games with the rec travel team schooled to the end of June and t-ball to the 4th week of July. Oakes stated that he is allowing the 7th and 8th school baseball programs to utilize the cities diamond two at Wings. Oakes asked who paid for the turface and lime supplies as Johnson stated the city has in the past. Meska asked if the programs were making money, Oakes stated no, that they bought all new uniforms, bats and hired umpires. Meska asked about comparing his program to others as Oakes stated that he has not compared his program to others yet. Oakes stated that he was misled when hired that he would be able to hire additional help. Oakes stated that he would like to work on Wings diamonds more. Meska asked if Oakes had any adult sports programs, as Cody stated no. Meska stated there used to be over a dozen adult softball teams years ago and that Wings Park was packed with games and talked about pickleball. Oakes stated that he was going to meet with Ehn about purchasing a \$60k turf tank to strip the fields. Oakes stated that he feels the diamond one bathroom and storage building should be torn down since he does not plan to use it.

Parks / Cemetery Updates:

Johnson stated that they have been dealing with a lot of cleanup and vandalism at Depot Park in the past few months. Johnson stated that they tipped over one of the steel benches and the memorial bench in the park. Johnson stated that they have cut out a piece of turf off the small mound and cut some of the flooring out.

Johnson said there is other damage and trash they spend 30-40 minutes cleaning up in the morning. Johnson stated that the Muller memorial bench base was poured, and the bench was installed along the trail just south of Wings Elementary School. Johnson said that the employees but out a couple of dead branches near the building this past month. Johnson stated that he and Justin put up all the shade covers at depot park and at the aquatic center before the opening day. Johnson stated that the drinking fountain they received through a grant through the Delta Dental Foundation arrived and is being put together. Johnson stated the value of this fountain is \$6,814.99. Johnson said that they are working on a few plumbing issues as they got the hose bib working at log cabin park for the events for RAGBRAI in July. Johnson stated that he and Justin installed the flag at diamond one as the rope broke over the winter and needed the bucket truck. Johnson said that while they had the bucket truck out, they did some tree trimming along the roadway in Platt Park. Johnson told the board that Justin has been doing a great job this season as he took it upon himself to trim the waterway between the pool and Wings Park. The employees finished up the playground safety fiber as they spread the remaining fiber in Platt Park and City Park. Johnson stated that this is from two semi loads that they had delivered as they completely removed all the mulch from the Wings Park playground area and replaced it during the day of caring. Johnson said that in April he Bouska and him asked businesses to donate funds to help finish installing yellow safety topper on the two remaining diamonds. Johnson said that they raised enough money to complete one diamond which they chose diamond two. Johnson stated that Tim Rivera and Joe Bouska helped with volunteers and the following businesses donated to purchase the tile, Manske's Corner Market, Berryman Dentistry, Midwest Collision, and Performance Rehab.

Johnson said that he had the street department conduct road patching and sweeping this past two weeks as they prepared for the contractor to come in and perform sealcoating several roads at the cemetery and City Park. Johnson said that they finished the cemetery last week and started on City Park today. Johnson stated that with the storms late last week they had quite a mess to clean up at the pool. A lot of leaves and seeds blew into the pool area and needed to be removed before swimming lessons started. Johnson stated that the small tree in front of the pool shower house and a large cottonwood tree in the back of Platt Park came down. The trees were cleaned up that day and the pool opened as usual.

Aquatics Update:

Johnson stated that the employees did an excellent job getting the facility ready this season. Johnson stated that they made a few improvements with the addition of a wall being installed in the storage room and cabinets put in to expand the concessions area. Johnson stated that they received the cabinetry from the wellness center that the hospital left behind in the physical therapy room that they cleaned out last year. Johnson stated that this will really help the concession staff with room to prepare food. Johnson said that Kim did a great job recruiting staff once again this year as most other facilities have struggled to find guards and have reduced hours. Johnson stated that they fully implemented the online program with the facility requiring everyone to pay for passes, swim lessons and rentals online this season. Johnson stated this has been a huge undertaking as he set up pool activities and passes, shelter reservations and campground reservations. Johnson shared the FB post with Casey Castle that created over 57 thousand views, 380 like and 40 comments to promote the facility.

Trails Update:

Johnson stated that segment two of the trail system has been bid on and the city received some very good low competitive quotes from contractors. Johnson stated that the lowest bidder was Baker Enterprises, Inc. for this segment. Johnson said that they are a very large construction company and have an office in Waverly. Johnson informed the board that the contractor is planning on starting after RAGBRAI has left town at the end of July. Johnson informed the board that he attended the upper explorerland meeting in Decorah this past month to discuss trial funding.

RAGBRAI:

Johnson stated that they have the google map done for the RAGBRAI people to post for all to see. Johnson said that they have talked to all the charters and are attending meetings as needed. Johnson stated that they will sell what they can out of the concessions that day and hopefully make some revenue for the department with food, showers, swimming, etc.
