Pledge of Allegiance Call to Order

Citizens Public Comments

Recognition of Service presented by Public Safety Chief Jeremy Logan.

Deb Scharnhorst, 400 Lincoln Dr NE, presented a petition to allow UTV's and golf carts to operate within the city limits. Approximately, 14 pages of signatures were received but over 60 of the signatures were from other communities and not residents of Oelwein.

Tim Buckman, 17208 25th Street, stated several local businesses drive across state highway 150 which is not allowed in state code.

Jason Shannon, 1116 1st Street SE, Fairbank coordinates two rides annually raising funds for local non-profits.

Public Hearing

4. Public Hearing to discuss the status of funding for the City of Oelwein water main improvements project.

Mayor DeVore opened the Public Hearing to discuss the status of funding for the City of Oelwein water main improvements project. Dianna Johnson oof Upper Explorerland Regional Planning Commission read the following required report to council:

- (a) a general description of accomplishments to date:
- The total project is approximately 46% complete. The 12th Ave SE water main and services have been completed. The 8-inch water main along 1st St NE is installed. The water services have been transferred along 1st St NE from 8th Ave NE to Elmwood Parkway. No water services have been transferred east of Elmwood Parkway.

- (b) a summary of expenditures to date:
- The latest pay estimate is current through January 26, 2022 and indicates that Community Development Block Grant (CDBG) reimbursable construction expenditures to date are at \$354,367.05 in terms of work completed and administrative expenditures are at \$23,248.43. The total CDBG expenditures requested-to-date is at 59%. Local match expenditures since January 26th have been \$409,804.67. There are still \$245,632.95 grant funds available to draw down.
- (c) a general description of remaining work:
- Water services need to be transferred to the new 8-inch water main along 1st St NE east of Elmwood Parkway. All water main improvements need to be completed along 5th St SE (5th Ave SE to 9th Ave SE) and 6th Ave SE (7th St SE to 5th St SE).
- (d) a general description of changes made to the project budget, performance targets, activity schedules, project scope, location, objectives or beneficiaries:

Since the CDBG end date is set for November 30, 2022 and the project is currently at 46% completed, there should be no need for an extension of the timeline of this project. We do not anticipate any changes in project scope, location, objections, or beneficiaries and expect field work and substantial completion to be done by September 30, 2022.

No further oral or written comments were received. Mayor DeVore closed the public hearing.
