Cantrell shared future considerations that property owners should have garbage removed, no demolition on garages, no demolition on non-city owned rental properties.

Community Development now inspects properties listed on Demolition Application requests. They must be dilapidated and not repairable.

Fisk stated there are several vacant houses that haven't paid the vacant house inspection fee for over four years. There are several reasons why this might happen. Some are acceptable while others are not. He is requesting council reviews this part of the policy.

Seeders inquired and Mulfinger responded that the city has no govern in determining Halloween activities. CDC has guidelines.

Payne inquired regarding the city noise ordinance. She also had trail questions. Mulfinger stated the trail ends at Levin Park but overall plans go to City Park.
