AN ORDINANCE PROVIDING FOR THE VACATION OF THE WEST PORTION OF THE ALLEY RUNNING EAST AND WEST ADJACENT TO LOTS 18-28 AND LOTS 30-41, BLOCK 2, IRVINE'S ADDITION TO OELWEIN, FAYETTE COUNTY, IOWA

BE IT ORDAINED by the City Council of the City of Oelwein, Iowa, as follows:

- Section 1. <u>Purpose</u>: The purposes of this Ordinance is to vacate THE WEST PORTION OF THE ALLEY RUNNING EAST AND WEST ADJACENT TO LOTS 18-28 AND LOTS 30-41, BLOCK 2, IRVINE'S ADDITION TO OELWEIN, FAYETTE COUNTY, IOWA, and thereby relieve the City of Oelwein of the responsibility for its maintenance and supervision.
- Section 2. <u>Facts Found</u>: The Council of the City Oelwein, hereby makes the following findings:
- A. The above described alley has been unused for the past several years and is not needed for use of the public, and therefore, its maintenance at public expense is no longer justified, except to retain an easement for public utilities.
- B. That the vacation of said alley will not deny owners of property abutting on said alley reasonable access to their property.
- C. Notice of the intended vacation, including the date on which the Council will first consider the vacating Ordinance, has been published and posted at least once along the described alley not less than four, nor more than twenty days before the date set for the hearing as provided in Section 363.3(1) of the Code of Iowa.
- Section 3. <u>Vacation</u>: The, WEST PORTION OF THE ALLEY RUNNING EAST AND WEST ADJACENT TO LOTS 18-28 AND LOTS 30-41, BLOCK 2, IRVINE'S ADDITION TO OELWEIN, FAYETTE COUNTY, IOWA subject to a retained easement for public utilities.
- Section 4. <u>Repealer</u>: All ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.
- Section 5. <u>Severability Clause</u>: If any section, provision or part of this Ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the Ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.
- Section 6. <u>When Effective</u>: This Ordinance shall be in effect after its final passage, approval and publication as provided by law.

 - Council should temporarily extend hours for sidewalk café to be the normal business hours for the restaurant with a limit being 10:00 PM
- 14-154 3. Amplified sound equipment shall not be permitted in the vicinity of a sidewalk café area.
 - Council should temporarily allow for music at sidewalk cafes that follows all local ordinances

Opening the sidewalk café rules will help restaurants as they adapt this summer to the pandemic. Should the city experience no issues during this summer, an ordinance change will be brought to City Council is the spring of 2020.

ARTICLE IX

SIDEWALK CAFE

SECTION 14-150. SIDEWALK CAFÉ DEFINED.

"Sidewalk café": An outdoor area temporarily located on a public sidewalk contiguous with any side of a building wherein a licensed restaurant is located and where food and beverages are taken for consumption by persons sitting or standing at tables in that area.

SECTION 14-151. AUTHORIZATION.

A sidewalk café in the public right of way may be operated only as set forth in this article.

- 1. A sidewalk café in the public right of way shall be permitted only in that portion of the C-1 Commercial Central Business District located along the Ten Block of North Frederick, Ten, One Hundred and Two Hundred Blocks of South Frederick, Ten Block of East Charles, Ten Block of West Charles, Ten Block of First Street SE, Ten Block of First Street SW, Ten Block of Second Street SE and Ten Block of Second Street SW.
- 2. The sidewalk café area must be contiguous with, and have direct access to, and shall be operated as an extension of a licensed restaurant or food establishment. Only licensed restaurants where more than 50% of the gross revenues in the past tax year were generated, on the premises, from the sale of food or beverages may request a permit to operate a sidewalk café.

SECTION 14-152. PERMIT.

- 1. A sidewalk café shall not be operated in the public right of way without first acquiring a permit therefore. The owner of the licensed restaurant shall file an application with the City Clerk on a form provided by the City. The applicant shall agree to abide by all terms of the permit and all state and local laws governing use of the public right of way. The application shall be accompanied with a photograph and detailed rendering depicting the location of all trees, flower beds, poles, benches, trash receptacles and other amenities or obstructions in the right of way, and the location of any proposed furniture or equipment. The application for a permit shall also be accompanied by a certificate of insurance with limits of liability established by Resolution of the City Council insuring against any and all claims of any kind arising out of the use of the public right of way, and applicant shall agree to hold the City harmless against any and all liability arising from or relating to operations of the sidewalk café or the location of the café' on the public right of way.
- 2. The application for a sidewalk café permit shall be accompanied by a fee established by Resolution of the Oelwein City Council. The permit shall be valid for 12 months from date of issuance, unless earlier terminated pursuant to this article.
- 3. The City retains the right to limit the number of sidewalk cafes permits issued. The City retains the right to terminate a sidewalk café permit after written notice of violation and time to cure the violation has expired. Grounds for termination of a permit shall include, but not limited to, violations of the terms of the permit, creating a nuisance or health or safety hazard. Additionally, the city retains the right to terminate the permit and direct removal of the sidewalk café operations if the Council determines there is a substantial and reasonable need for use of the public right of way for a valid public purpose and applicant shall receive a pro rata refund of the permit fee.

SECTION 14-153. DESIGNATED AREA.

- 1. A sidewalk café area may encroach into the public right of way and shall be located and operated in a manner that will allow a minimum of four (4) feet of unobstructed sidewalk adjacent to the street curb for pedestrian use. Obstructions such as street lights, planters or other public amenities shall be outside the required minimum four (4) feet of unobstructed sidewalk.
- 2. No tables or chairs shall be anchored to the public right of way. All tables and chairs and other equipment and amenities shall be removed from the public right of way and the sidewalk café area shall be cleaned and restored to a pedestrian way at the end of each day's operation.
- 3. A sidewalk café area shall not appropriate or include any public amenities, benches or trash receptacles.
- 4. The use of the public right of way shall not interfere with access to public utilities located and operated within the public right of way.

SECTION 14-154. SIDEWALK CAFÉ OPERATIONS.

- 1. No alcoholic beverages may be served or consumed in the designated sidewalk café area.
- 2. A sidewalk café may be operated any day of the year the licensed restaurant is taking food and beverage orders from patrons between the hours of seven o'clock (7:00) A.M. and Twelve o'clock (12:00) P.M. The sidewalk café area shall be restored to and maintained as a pedestrian way at all other times.
- 3. Amplified sound equipment shall not be permitted in the vicinity of a sidewalk café area.
- 4. Advertising shall not be permitted in the sidewalk café area except the name of the establishment may be placed on chairs, tables, umbrellas or other amenities.
- 5. All furniture, equipment and amenities associated with operation of the sidewalk café shall be clean and maintained in good repair and removed from the public right of way at the end of each day's operations.
- 6. All furniture, tables, chairs and amenities shall not be located within four (4) feet to a street (alley) and shall remain within the approved boundaries of the sidewalk area as shown on the restaurant owner's application.
- 7. No handicap aprons, building entrances or exits shall be blocked by a sidewalk café.
- 8. A sidewalk café area shall be subject to inspection at any time.
- 9. The licensed restaurant owner and operator of a sidewalk café shall be responsible for trash removal and shall maintain the area within ten (10) feet of the sidewalk café area in a clean and litter free condition during all hours of operation.

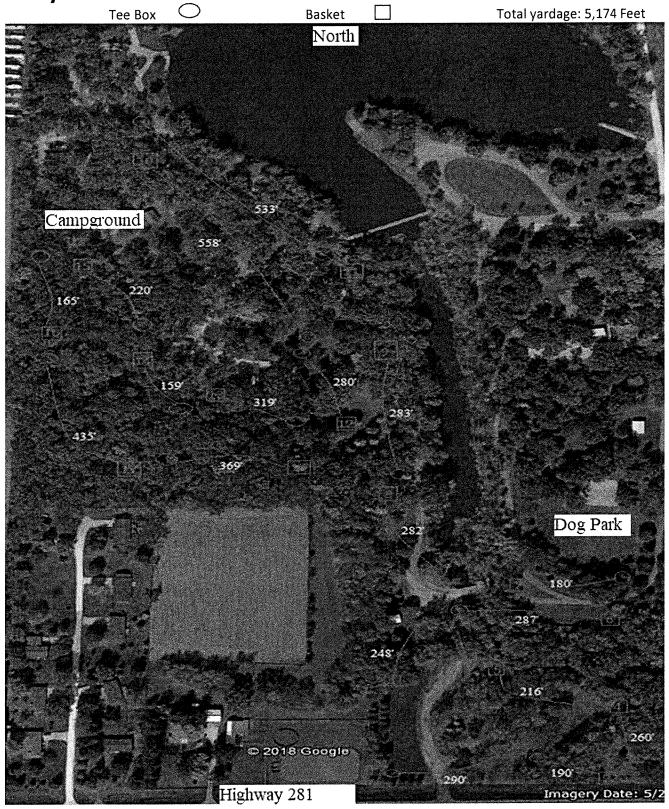

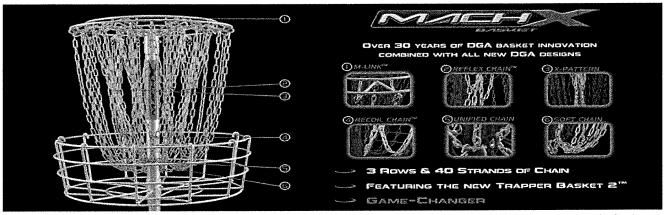

The city needs a new format for helping residents with spring cleanup. The pandemic will not allow for a safe event and changes are needed. City Council discussed at their June 15 work session to expand the large item sticker program for Oelwein. Customers can currently buy a sticker for \$15.00 and set their items on the curb for Black Hawk Waste to pick it up on the first week of the month on their regular service day. City Council has worked with Black Hawk on a two-month program that will start in July and end in August.

Residents will have the option to pay \$5.00 for a sticker to have a large item picked up on their regular service day. Residents can call into city hall to purchase their sticker. City Hall can charge it directly to the utility bill and residents can come down to city hall to pick up the sticker. Residents will be required to list the item they are setting on the curb so that Black Hawk Waste is prepared for the item.

The following items will be accepted:

- Couch
- Chair
- Table
- Dresser
- Mattress
- Box Spring
- Child Toys
- Appliances
- Carpet (small remnants, no remodels)

Items that are not accepted:

- Electronics
- Metals
- Oil

The program will start July 6 and run until August 28. The City will offset the cost of each ticket using local option sales tax dollars that normally go to the city-wide cleanup. There is no limit to stickers per property. All requests for a pickup must be made one week in advance. Residents are asked to put their items on the curb near their normal pickup area the night before their designated pickup.

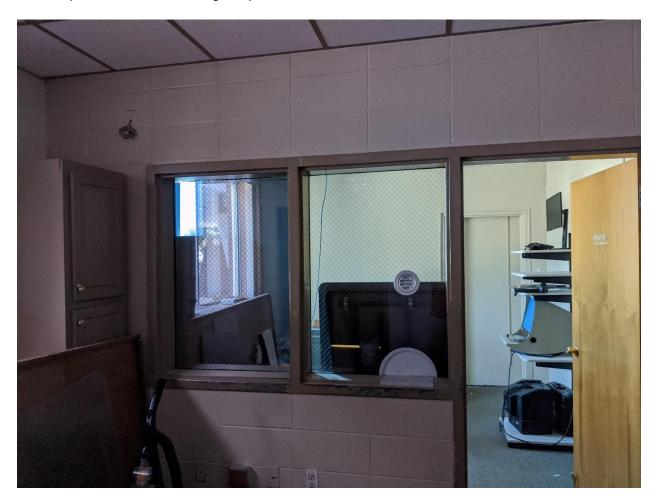
The City Hall improvement plan will allow for employees in City Hall to social distance during the current pandemic. All improvements will help with service to the community and provide a safer office space for employees at City Hall. The City Administrator is requesting that council allow for an expeditated process for improvement where the Administrator will get two quotes from each company contracted, then accept the low bid. This expeditated process will help the city on the goal of opening City Hall.

The following improvements will be made:

- Front door will be equipped with a buzzer system
- The City will install two new service windows with an option for a third if budget allows
- The City will purchase new office equipment for the new offices
- Sheet rock will be removed to mitigate any mold
- Tables will be brought in to allow for patrons to sign documents
- Old jail cells will be converted into restrooms

The City Council budgeted \$80,000 for improvements to City Hall in FY2021. The goal for this project is to spend under \$30,000. These improvements will allow for City Hall to be open to the public and stay open should the pandemic become worse in the fall. These improvements also set up a better facility and allow for more room for employees and a different setup once conditions improve in the future.

The first picture shows an existing setup that I like.



The first window goes into non loading bearing block wall. The block is 16*8. The window would need to be 64 inches wide 32 inches tall. We would need a service panel in this window. It would be at counter height.



The second window would be another service window. This wall is a non-load bearing sheet rock stud wall. Same dimensions as the window above.



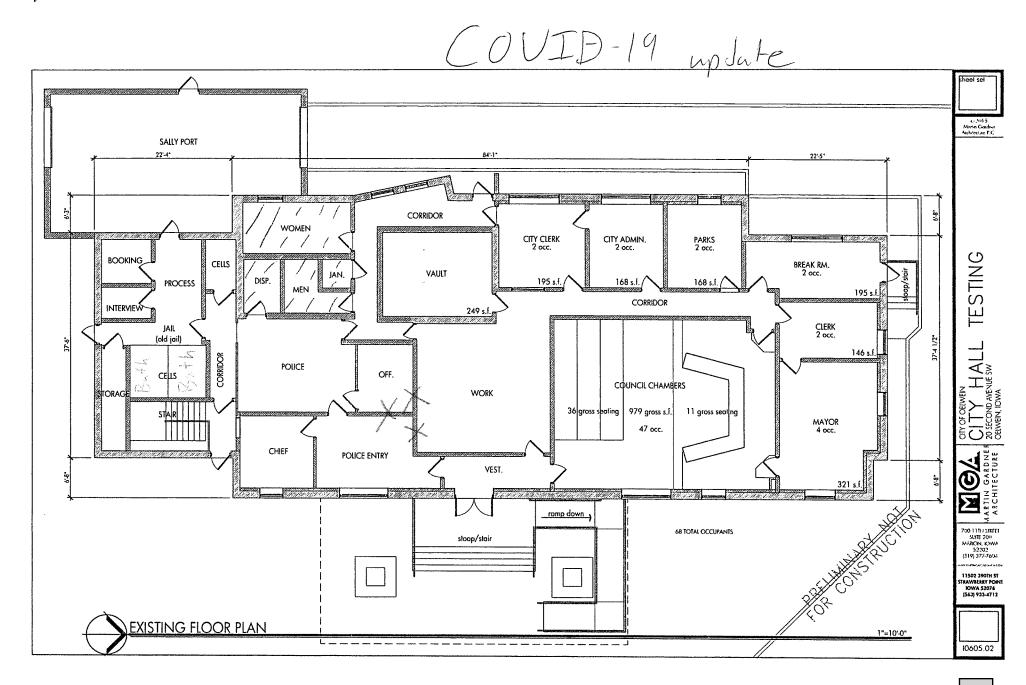
The two service windows would ideally be some type of safety glass.

The third window would be so that one office could see the larger office. Just for viewing and not for serving. If you have a recommendation or a standard size, I am okay with that. Otherwise, 64*32 works for me.





The last option would be for a new main service window. It would match the other service windows and be removing an older window. This wall is non-load bearing block. Same size as the other service windows.



Library Minutes June 9, 2020

The Oelwein Public Library Board of Trustees held its regular board meeting on Tuesday, June 9, 2020 at 5:00 p.m. This meeting was held electronically due to the State Public Health Emergency Declaration regarding COVID-19. The meeting was conducted pursuant to Iowa Code 21.8 and the Proclamation of Governor Kim Reynolds dated March 19, 2020. Public input was able to be provided by joining the prepublicized GoToMeeting.

Present electronically: Berryman, Mars, Gilson, Kerns, Gerdts, and Macken Absent: Ingersoll

Vice-president Mars called the meeting to order at 5:08.

Gilson made a motion to approve the agenda and the minutes. Seconded by Berryman. Motion carried. No correspondences.

Trustee Training: The board reviewed the standard on tracking public internet usage.

Director's Report:

- IaShares book delivery van starts back up this week. Inter-library loans are no longer suspended.
- The LED conversion project is being done this week. Not all fixtures are being upgraded. The T-8 4 foot bulb fixtures are being converted.
- The Annual Maintenance Schedule has been completed for the year. New monthly duties added are cleaning computer components when running the software updates, and cleaning the children's area toys and furnishings.
- The iPads, kiosks, and wireless keyboards have arrived to assist with the Census. Funds were obtained from the National League of Cities Rapid Response grant.
- The director arranged to have the shelf moving system delivered to the library from Wisconsin instead of having a member from the Friends of the Library pick it up in one of their vehicles. The unit weighs 1400 pounds plus there are still a number of restrictions due to the pandemic.
- The sofas were delivered, but the driver informed staff that they only deliver curbside. The
 order included "white glove" delivery meaning the sofas would be placed, uncrated, inspected
 for damage, and the shipping materials would be hauled away. A volunteer will uncrate the
 sofas, and the director is in contact with the furniture company for the refund for the services
 not rendered.
- Eighty-three adults, teens, and children are registered for the Summer Reading Program.
- Ken's Electric is repairing the HVAC. The air-conditioning is not working. There is a leak in the pipe near the compressor that was replaced a couple of months ago.
- With the heavy rain throughout the day, staff found leaking on the ceiling in the reading room and by the window in the children's area. The board would like the director to notify the Building Inspector and the City Administrator.
- A new rotation of officers will commence in July.

Friend's Report:

- Friends planted flowers in the entryway planters.
- A book and bake sale are being planned for October.
- The June meeting has been delayed.

Gilson made a motion to approve the list of bills. Seconded by Berryman. Motion carried.

The "Conduct in the Library" policy was reviewed. Staff recommends removing the section on Cell Phones. Gilson made a motion to accept the policy as revised. Seconded by Berryman. Motion carried.

Gilson made a motion to adjourn at 5:42.

Policy

The Oelwein Public Library provides a safe, comfortable environment conducive to the use of library materials and facilities. The library is intended for the use of all members of the public. Patrons are expected to observe the rights of other patrons and staff members and to use the library and the library grounds for its intended purposes. Misconduct will not be allowed on the library premises.

Misconduct

Misconduct is behavior that is illegal or that:

- interferes with the rights of individuals to use library materials, services, and premises which includes the inside and outside areas of library property
- interferes with the ability of library staff to conduct library business, or
- threatens the secure and comfortable environment of the library or those using the library.

Misconduct may include, but is not limited to the following:

- Willfully annoying, harassing, or threatening another person. [Harassment is defined as any action taken or situation created intentionally to produce psychological or physical discomfort, embarrassment, or ridicule. Harassment is characterized by requests for sexual contact, unwelcome physical advances, or conduct (verbal or physical) of a nature that is intimidating, demeaning, hostile, offensive, or potentially dangerous to self or others.]
- Any behavior that endangers or could endanger the safety or health of others.
- Behaving in a disorderly, loud, or boisterous manner which disturbs or could disturb other patrons.
- Using abusive or profane language.
- Theft, vandalism, or the deliberate destruction of library materials, property, or the personal property of patrons or staff members.
- Maliciously accessing, altering, deleting, damaging, or destroying any computers, peripherals, computer system, network, computer program or data.
- Entering the non-public or locked areas, unless accompanied by a staff member or through prior authorization from a staff member.
- Leaving personal items in the building. The library assumes no responsibility for any personal belongings left unattended.
- Using personal electronic devices without earphones or with earphones at an unreasonable volume.
- Distributing or posting material without library staff approval.
- Picture taking or video taping of individuals unless authorized by the individuals involved or their parents if minors are present.
- Soliciting of sales or selling to library patrons except at library-sponsored events.
- Bringing animals into the library, except those trained to assist individuals with disabilities or for library-sponsored events.
- Using tobacco products or smoking on the library premises.
- Using alcohol on library premises.
- Using the library for inappropriate purposes such as sleeping and bathing.
- Wearing inappropriate dress such as bathing suits, no shirts, and no shoes.
- Eating or drinking in areas not designated for these activities.
- Use or threat of use of dangerous weapons, including all firearms. [Dangerous weapons are as defined in Section 702.7 of the Code of Iowa and include, but are not limited to any offensive weapon, pistol, revolver, or other firearm, dagger, razor, stiletto, switchblade knife, or knife having a blade exceeding five inches in length.]
- Violation of any municipal, state, or federal law or code.

Petitions:

No group or individual may circulate petitions in the library building. Petitions may be circulated outside the facility at a reasonable distance from the library, however, patrons must be allowed free access to the facility, and harassment or intimidation of patrons will not be tolerated.

Consequences:

The Library Director or delegated staff shall have the responsibility for enforcing discipline within the library and will determine misconduct. [Children under age seven (7) must be accompanied by a responsible person at least fourteen (14) years old. It is their responsibility to supervise and monitor the behavior and safety of their children at all times.]

Enforcement of these rules may take the form of any of the following actions, depending upon the severity of the misconduct which will be determined by the staff on duty at the time.

Warning:

 Patrons who engage in misconduct will be given one warning and asked to conduct themselves in an appropriate manner.

Expulsion:

- Patrons who do not modify their conduct after one warning will be asked to leave the library for the rest of the day.
- Patrons who engage in misconduct that, in the judgment of a staff member, is extreme will be asked to leave the building for:

First offense : 1 month
 Second offense : 6 months
 Third offense : 1 year

Subsequent offenses: 1 year

 The person whose library privileges are suspended shall be advised, in writing, of the suspension and the reason for such action. The suspended person shall also be informed that the suspension may be appealed at the next regularly scheduled Library Board meeting.

Police:

• If a patron appears dangerous, deliberately violates the law, is identified as a registered sex offender against a minor, or refuses to leave the library after being asked to leave, the director or the senior staff member on duty will call the police.

Parks/Cemetery Report Johnson reported that mike Ledesma has been working on the downtown streetscape watering the hanging baskets every day. Johnson stated that he put a new section on the parks website about tree board information and park updates. Johnson stated that all the bathrooms are open in all the parks and that the finished diamond one water lines. Johnson said that at red gate park they have planted 11 trees and have 6 large trees transplanted from the tree nursery. Johnson stated that with the flooding event last week they had damage in most areas. At Wings Park, diamond 1 had the surface washed out around the backstop and fence damage. Johnson said the first thing the workers completed was pushing mulch back into flowerbeds downtown and move on to other parks. Platt Park had some playground mulch washed out and 4th St. SW that the cemetery crew maintains had debris on it. Johnson stated that the campground host was told that night that there would be flooding overnight into the morning. Campers were able to drive out by 8:30 the next morning. Johnson stated that the pool went over an LED conversion to replace light fixtures. Johnson stated that there was an issue with the starter on the main circulation motor, which they had repaired. Johnson stated that the pool has been filled to protect the liner and signage up, surveillance system on pool and chemicals are kept at a minimum. Johnson stated that block signs were installed at Woodlawn cemetery to help with identification. Stewart has been working on the new sign that has been donated to the city for the cemetery. Johnson stated that the guys are working on water lines that were ripped out due to the tornado ripping trees out of the ground that damaged these lines. Johnson said that they have had 18 graves and 8 cremations this year so far with 4 more cremations scheduled. Johnson stated that due to relaxed COVID-19 restrictions families are having more burials now. Johnson said that the Wings trail project has the dirt work completed but the contractor needs to finish two problem areas. Johnson asked the board members to submit a letter of support for the REAP grant that he is submitting for trail funding.

Recreation Report Burkhart stated that little league started practicing in June and they will only have grades 4-7 softball and baseball. Burkhart stated that she has had some dropouts due to COVID-19 concerns. Burkhart said that some games have been rescheduled due to the flooding damage at diamond one. Burkhart said that adult leagues will start at the end of July and she is going to survey to see what interest there is in men's and coed leagues. Burkhart stated that she is hiring new umpires and the wellness center has been open a month now. The wellness center has had slow traffic as seniors are hesitant to come in and there is no silver sneakers. The governor has opened to 100% capacity and they are getting CPR certifications renewed.

- 1. The original ordinance for sidewalk cafes is too restrictive to help any of the downtown businesses. This trial run for 2020 should be a welcome relief to business owners who want to expand dining options during the pandemic. The City Administrator recommends approving the resolution.
- 11. Consideration of a Resolution approving contract and performance and/or payment bonds for the Wings East Pavement Improvements Project
 - 1. The city must formally accept bonds for the wings east project. The City Administrator recommends approving this resolution.
- 12. Consideration of a Resolution Directing the Sale of the City's Interest in 312 1st Avenue NW, Oelwein, Fayette County, Iowa
 - The City had offered this property to one property owner three years ago in an attempt to no longer own this vacant lot. That transaction did not go through.
