- ➤ One Million Trees planting: Johnson stated that he had called in locates for all the locations and the park department will be preparing the holes ahead of time. Johnson stated that he will be picking up the trees the day before the planting as the trees were split between Cannons and Manske's equally. Board members agreed to meet at the shop at 7:30am Wednesday Oct. 16<sup>th</sup> where they will move to the first planting location for a tree planting demonstration as Johnson stated that he will send a reminder to Bri Hull, the Trees Forever representative and Alliant Energy.
- ➤ Gravel bed tree planting AmeriCorps, Trees for Kids planting: Johnson reviewed the planting with the board as the planting went well. Johnson thanked the board members for helping with this planting. Johnson said that Jeff, Lou Ann & John



helped remove the trees from the gravel bed and all were impressed with the root systems. Board members were happy with the help given by the AmeriCorps members that Johnson lined up. Johnson talked about the Trees for Kids planting at Platt Park the previous Wednesday. Johnson thanked board members for attending and stated that the planting went great. Johnson stated that kids were helpful and Chip Murrow with the DNR was very helpful and supportive of the boards work as they talked a great deal after the planting.
