CALL TO ORDER - The meeting was called to order by Chairperson Lane at 4:01 pm.

CONSENT CALENDAR

A. Approval of Economic Development Commission Minutes from April 9, 2024

ACTION: Commissioner Hoffman moved, seconded by Vice Chairperson Smith to approve consent calendar as presented. Motion carried by a voice vote, 3-0.

ITEMS FOR DISCUSSION OR ACTION

A. Follow-Up Report on I-5 Feasibility Study, Visioning

City Manager Pete Carr reviewed the recently added "Prospective – Investment Opportunities in Orland" on the City website, summarizing examples of various development opportunities in Orland. He discussed three key development sites with the commission, providing a brief overview of each. This 19-page document draws highlights from the I-5 Economic Development Study and the Opportunity Zone document.

Mr. Carr shared that at the next City visioning meeting, Council would like to invite the Economic Development Commission and Planning Commission, either on July 23 or July 30th.

B. Consider establishing a Revitalization District

Vice Chairperson Brandon Smith proposed the creation of a revitalization district to enhance and preserve Orland's aesthetics.

The commissioners engaged in a discussion, asked questions, agreed this is a good topic to bring up at the visioning meeting.

C. Consider all taxes and fees collected by the City for development

Mr. Carr provided a brief explanation of impact fees for residential and commercial properties, and reviewed examples.

Commissioners then discussed various strategies to incentivize property sales and upgrades, fee reductions for new businesses. and addressed the fees associated with residential and commercial properties. The Commission requested City staff to present three or more options or examples of potential incentives and fee reductions for prospective businesses.

D. Chamber Report

Chamber President/Commissioner Jackson shared a few upcoming events including:

- Spring Farmers Market has ended but the Chamber is hoping to have the market open July 12th, Aug 9th and then every Friday in September (Vice Chairperson Smith shared that the Chamber is looking for more vendors for the market, not just produce but artists and goods;
- The Senior Expo is being held on June 27th at the Fairgrounds;
- A promotional video of Orland is in the works and will take many months to complete.

E. Business and Economic Development Update

Mr. Carr shared with the Commission:

- The Bees have been installed on the I-5 off/on ramps;
- Sparrow and Crow will be closing its doors;
- Two hotel developers have visited Orland but decided the properties didn't work out for their needs:
- CHIP has turned in the first 24 State subsidy applications, but all actions have now been halted due to a State spending freeze.

Dear Southern Pacific Corp:

The Orland Economic Development Commission (EDC) has the responsibility of recommending to the Orland City Council actions that can be taken to improve the economic climate and opportunities in our town. We have identified your commercial property:

1001 Sixth Street

Orland, CA 95963

as one qualifying for certain incentives and code enforcement treatment:

- 1. The City offers its Façade Improvement program to you as a 50¢-on-the-dollar reimbursement for your reinvestment in improving the appearance of your building. This is a simple, locally controlled (not State of California) program, available while funds last, normally up to \$3000 reimbursement.
- 2. Demolition permit, site plan, use permit and building permit fees may be reduced or waived on a case-by-case basis for reinvestment in your building, upon your request.
- 3. The Orland Art Commission offers free consultation in attractive architecture and color schemes.
- 4. City Staff and 3CORE consultants can work with you on an advisory basis, at no charge to you, to help you explore options and processes.

Please contact City Hall for more information on any of the above three opportunities.

You should also be advised that the City recognizes that vacant buildings increase the City's burden to provide police patrol as well as law enforcement, fire and rescue response. Vacant buildings tend to attract vagrancy, rodent harborage and graffiti, and are generally a blight to the neighborhood and town. Apparently abandoned buildings detract from economic development and depress real estate values generally.

6. A.

Consequently, the Orland Municipal Code provides for active code enforcement including fines for owners of buildings determined to be dilapidated and/or dangerous. It is our hope to work with property owners to take advantage of incentive opportunities and avoid negative consequences.

Please reach out to any of our Commission members or to City Hall to explore what can be done to improve the appearance and potential reutilization of your vacant property.




Governor's Office of Business and Economic Development (GO-Biz)

The California Competes Tax Credit is an income tax credit available to businesses that want to locate or stay and grow in California. A total of \$644,756,695 in California Competes Tax Credit is available for allocation in the 2024-2025 fiscal year.

Application Periods

About the Credit





- January 6, 2025, to January 27, 2025 \$215 million available
- Online application
- February 24, 2025, to March 10, 2025 \$214.7 million plus any remaining unallocated amounts
 - No fee to apply

Evaluation Factors

- Number of jobs created or retained
- Strategic importance to the state, region, or locality
- Training opportunities offered to employees
- Incentives available from in-state, out of state, and federal government sources
- Opportunity for future growth and expansion
- Extent to which the credit influences decision to relocate jobs into California from states that have enacted laws that: permit discrimination on the basis of sexual orientation, gender identity, or gender expression; or deny or interfere with women's reproductive rights

- Compensation paid to employees, including wages and fringe benefits
- Extent of unemployment and poverty in current or proposed site location
- Economic impact
- Duration of the proposed project and applicant's commitment to remain in California
- Extent to which the benefit to California exceeds the benefit to the applicant
- Extent to which the credit influences creation of new California jobs
- Commitment to treating workforce fairly and creating quality, full-time, wage and salary jobs
- Amount of investment
