# ECONOMIC DEVELOPMENT COMMISSION REGULAR MEETING MINUTES Tuesday, November 14, 2023

**CALL TO ORDER -** The meeting was called to order by Chairperson Lane at 6:00 pm.

PLEDGE OF ALLEGIANCE – led by Commissioner Smith.

## **ROLL CALL**

Commissioners Present: Ron Lane, Russell Pierce, and Dee Dee Jackson

#### **CONSENT CALENDAR**

ACTION: Chairperson Lane moved, seconded by Commissioner Pierce to approve consent calendar as presented. Motion carried by a voice vote, 4-0.

# **STAFF REPORTS**

## A. Review Quarterly Sales Tax Results

Mr. Carr updated the Commission on the City's quarterly sales tax results for April – June 2023. Commissioners asked questions and discussed fuel revenues.

Chairperson Lane introduced the new Commissioner, Brandon Smith. Mr. Smith thanked the City for the opportunity and shared with the Commission a little background on himself.

## **B.** Business Support Program Updates

#### \*Facade Improvement Program

Mr. Carr shared that the last few months have been very slow for the façade improvement program stating that no new businesses applied since his last update but still currently 3 businesses pending.

# \*Queen Bee Bucks Program

Mr. Carr shared that Queen Bee Bucks sales and marketing has slowed down but the City is getting ready to do another launch during the holiday season to coincide with the Orland Chamber of Commerce's Plaid Friday and Cowboy Christmas.

# \*5th Street/Honeybee Discovery Center Lot

Mr. Carr shared that there is no news or information on the Honeybee Discovery Center. Mr. Carr announced that the City did not receive the grant for the pollinator park.

# \*Streetscapes

Mr. Carr explained that he is working with PG&E and local businesses on lampposts in the downtown area. Mr. Carr shared that trash receptables have been ordered and that benches will be ordered soon.

Mr. Carr shared that Caltrans will be starting a project in 2025 called OJ500 where the roads will be reconstructed, and sidewalks will be added with ADA ramps along SR 32.

## C. Local Business and Development Updates

Mr. Carr provided an update on Maverik, sharing that they hope to be open by December. Currently Maverik is waiting on PG & E to power their building and to complete power to the new traffic signal on Commerce. Chairperson Lane stated his concerns with the lack of reflectors, striping and signage at Commerce, sharing many people are confused at the intersection.

Mr. Carr shared that he reached out to Sunny's Truck Wash two weeks ago but has not heard back from them yet.

Mr. Carr stated City Staff met with Dutch Bros representative and the property owners and they feel like the new queuing process is working for them and keeping employees and patrons safe. Commissioners agreed that the new queue setup is manageable.

Mr. Carr shared that he has been in contact with a few hotel investors, and he provided research and feedback the investors offered to the City on building a hotel in Orland. Commissioners discussed and shared ideas on getting investors to choose Orland for a hotel.

# D. Chamber and Glenn Grows Update

Commissioner Dee Dee Jackson shared that the Chamber recently hired a new employee and gave a brief update on upcoming events for the Chamber including Cowboy Christmas December 1<sup>st</sup> and the Christmas parade December 10th. Commissioner Jackson shared that the Chamber has no new information on moving into the Glenn Grows building.

#### ITEMS FOR DISCUSSION OR ACTION

Mr. Carr shared that a year ago the City Council approved the collaboration with Glenn County to match a grant from the State for economic development, where a consultant was hired to do an economic feasibility study on the I-5 corridor. Mr. Carr shared he will be emailing the Commission a link to the I-5 study for the Commission to review before the January meeting.

## A. Business Friendly Check-up Report from Regional Government Services

Mr. Carr briefly presented to the Commission the results from a recent business friendly check-up questionnaire he completed from Regional Government Services (RGS).

Chairperson Lane asked if RGS offers suggestions on how to improve score. Mr. Carr presented additional information to the Commission and invite feedback.

- Commissioner Jackson suggested she would like to create a visitor guide/brochure of Orland showcasing restaurants, businesses, and upcoming events. All Commissioners agreed they would like to discuss more on a future agenda.
