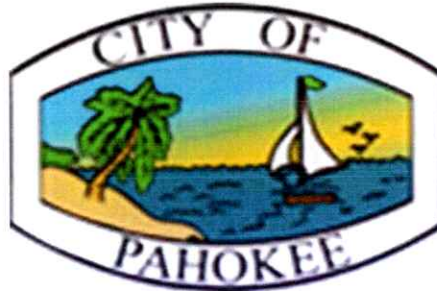

Commissioner Gonzalez thanked everyone that showed up and advised we need activities for the girls in our area.


Mayor Babb advised we are having a quarterly citywide cleanup on September 24th, in front of Public Works Department.
