#### **GENERAL SUMMARY/BACKGROUND:**

Pursuant to Section 200.065(2)(e)2., Florida Statutes, hearing dates scheduled by the county commission and school board shall not be utilized by any other taxing authority within the county for its public hearings. The Palm Beach County Board of County Commissioners has its first budget hearing scheduled for September 9, 2025, and its second hearing scheduled for September 16, 2025. The School Board of Palm Beach County has its first budget hearing scheduled for September 10, 2025.

The City Commission of the City of Pahokee has previously discussed and reviewed the tentative budget schedule, including the need to avoid conflicting dates with the county and school board hearings. The rescheduling of the City Commission meeting has been shared on multiple occasions, including, but not limited to, the budget schedule and during discussions at Commission meetings.

This item is being presented to the City Commission to formally cancel the September 9, 2025 meeting and reschedule it to September 8, 2025. This ensures compliance with Florida Statutes and allows the City Commission to conduct a tentative budget hearing without scheduling conflicts.

#### **BUDGET IMPACT:**

There is no fiscal impact associated with the rescheduling of this meeting.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PAHOKEE, FLORIDA, APPOINTING AN ADVISORY BOARD LIAISON; PROVIDING FOR ADOPTION OF REPRESENTATIONS; PROVING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Article V, Section 2-162 of the City of Pahokee's Code of Ordinances, requires that the Parks and Recreation Advisory Board "consist to of five (5) members who are citizens of the city and who are appointed for two-year terms by the city commission"; and

**WHEREAS**, pursuant to Section 2-162 of the City of Pahokee's Code of Ordinances, one member of the city commission, who shall not be a voting member, shall be appointed as the liaison to report back to the City Commission any recommendations of the advisory board; and

**WHEREAS**, the Code of Ordinances further provides that such board shall assist in the planning for city recreational and playground sites, activities, plans, capital improvements, guidelines, programs, and any other matters at the request of the city commission or city manager; and

WHEREAS, the duties of the advisory board shall be to "assist in the planning for city recreational and playground sites, activities, plans, capital improvements, guidelines, programs, and any other matters at the request of the city commission or city manager"; and

**WHEREAS**, the current members of the Parks and Recreation Advisory Board are: Jacob Finkel, Artiona Hickman, La'Ciera Reddick, Andrea Scott, and Alphonso Smith, Jr.; and

**WHEREAS**, pursuant to Resolution 2024-28, the City Commission of the City of Pahokee ("City Commission") appointed Commissioner Derrick Boldin to serve as Parks and Recreation Advisory Board Liaison; and

**WHEREAS**, Commissioner Derrick Boldin resigned from office effective July 21, 2025, leaving a Parks and Recreation Advisory Board Liaison vacancy; and

**WHEREAS**, the City Commission desires to appoint one (1) commission member liaison to serve in this role.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE
