MEETING NOTICE AND AGENDA Paradise Sewer Regionalization Project Advisory Committee Meeting Monday April 12, 2021 1:00 PM to 3:00 PM

PURPOSE OF THIS MEETING

The Town of Paradise (Town) has identified a connection to the Chico Water Pollution Control Plant (WPCP) as its preferred alternative for wastewater treatment and disposal and has approached the City of Chico (City) to explore the feasibility of such a regional project. The Councils of the Town of Paradise and City of Chico have agreed to form a Sewer Regionalization Project Advisory Committee (Committee) as a mechanism for exploring this proposal.

The committee will: (1) Monitor progress of the Paradise Sewer Project, including the Project's Environmental Impact Report (EIR), and efforts being done under the Town and City's Cooperative Work Agreement, (2) Develop the Principles of Agreement for an inter-municipal agreement between the Town and City, and make a recommendation on those Principles to the two Councils if applicable, and (3) Guide public participation in the EIR process which will happen separately but in parallel with the Committee's work.
