

**MINUTES

1. OPENING

The Special meeting of the Paradise Town Council was called to order by Mayor Bolin at 9:15 a.m. in the Town Council Chamber located at 5555 Skyway, Paradise, California who led the Pledge of Allegiance to the Flag of the United States of America.
