

## MINUTES PARADISE TOWN COUNCIL SPECIAL MEETING – 2:00 PM – August 21, 2025

## 1. OPENING

The Special meeting of the Paradise Town Council was called to order by Mayor Crowder at 2:00 p.m. in the Council Chambers located at 5555 Skyway, Paradise, California who led the Pledge of Allegiance to the Flag of the United States of America.

**MOTION by Lassonde, seconded by Crowder** approved adding Government Code Section 54957 to meet with the District Attorney Related to matters posing a threat to the security of public buildings, a threat to the security of essential public services, including a threat to the public's right of access to public services or public facilities, or a threat to critical infrastructure controls or critical infrastructure information relating to cybersecurity to the agenda.
