# Measure C Oversight Committee Meeting Minutes

4:00 PM - April 28, 2020

#### 1. OPENING

The April 28, 2020 meeting of the Measure C Citizen Oversight committee was called to order by Chair Knappen, via telephone conference, at 4:07 p.m. who led the Pledge of Allegiance to the Flag of the United States of America.

#### 2. ITEMS

2a. The Measure C Citizen Oversight Committee acknowledged the resignation of Kirk Trostle effective March 15, 2020 and the replacement of Linda Dye as a regular member of the Measure C Citizens Oversight Committee approved by the Town Council on April 14, 2020.

Committee Member Jones nominated Committee Member Buzzard to serve as the Vice Chair for the remaining term ending June 30, 2020. There were no other nominations.

All Members present, on the phone, concurred to close the nominations.

**MOTION** by Jones, seconded by Knappen, approved the nomination of Committee Member Buzzard to serve as the Vice Chair for the remaining term ending June 30, 2020. Roll call vote was unanimous with members Fender, Hansen and Morris. Jr. absent and not voting.

- 2b. MOTION by Buzzard, seconded by Dye, approved the minutes of the October 22, 2019 Measure C Citizen Oversight Committee meeting. Roll call vote was unanimous with members Fender, Hansen and Morris, Jr. absent and not voting.
  - **MOTION by Simonton, seconded by Jones,** approved the minutes of the January 28, 2020 Measure C Citizen Oversight Committee meeting. Roll call vote was unanimous with members Fender, Hansen and Morris, Jr. absent and not voting.
- 2c. Administrative Services Director/Town Treasurer Gina Will provided a Financial update to the Committee. Ms. Will stated that revenues are less than pre-fire and there is uncertainty what the impact will be from COVID-19. The anticipated revenues for the entire 2019/20 year are budgeted for approximately \$750,000. Expenses for the canine program may be more than expected due to a new canine being put into service, but there will be a formal request for additional funding brought back at the next meeting. There were no questions from the Committee.
  - **MOTION by Buzzard, seconded by Knappen,** approved the quarterly report from the Measure C Citizens Oversight Committee to the residents of Paradise for the 3rd quarter of the 2019/2020 fiscal year. Roll call vote was unanimous with members Fender, Hansen and Morris, Jr. absent and not voting.
- 2d. Administrative Services Director/Town Treasure Gina Will presented a draft 2020/21 Measure C Budget to the Committee stating that the projections were conservative due to the uncertainty of the economy at this time. The budget will be brought back to the Committee prior to being forwarded to the Town Council for final approval. There were no recommendations for adjustments from the Committee.

### **Committee Action Requested:**

1. Discussion of the 2020/21 budget

2. Approve the proposed Measure C expenditures for the 2020/21 fiscal year

#### Background:

Measure C, the 0.50% the six-year, temporary transaction and use tax expires on March 31, 2021. The 2020/21 budget is for the sixth and final year.

#### **Discussion:**

The proposed Measure C 2020/21 budget has only received small modifications since the last discussion held with the Oversight Committee on April 28, 2020. For the most part, it is a refinement of the expected expenditures based on analysis of the current and past budgets. Specific line items or types of expenditures have not changed. A copy of the proposed 2020/21 budget and revised financial plan is attached for your review.

#### Conclusion:

This proposed conservative budget and financial plan leaves approximately \$885,000 in reserves. This reserve provides some cash flow support in case the PG&E settlement is delayed. Once the PG&E settlement is secured, the monies can be used as matching funds for important recovery grants; as matching funds for capital improvement projects; or to continue the replacement of critical public safety vehicles and equipment.

Measure C to date has been extremely helpful in preserving services and repairing and replacing long deferred capital improvements just as it was intended. Your participation in the process and commitment to ensuring that the funds be used appropriately was invaluable. The established process and the remaining funds are a great way to transition between Measure C monies and Measure V monies. Recovery grants, insurance monies, the PG&E settlement partnered with remaining Measure C and the new Measure V monies will allow the Town of Paradise to support a resilient and thriving community.
