SUBJECT: Final Candidate Selection for the Measure C Oversight Committee

COUNCIL ACTION REQUESTED:

1. Review the recommendation of the Measure C Oversight Selection Committee;

- 2. Conduct wrap-up dialogues with the twelve finalists;
- 3. Select and appoint nine applicants to form the Measure C Oversight Committee; and,
- 4. Appoint the remaining three finalists to serve as alternates for the term of the committee.

Background:

In the November 2014 general election, the citizens of Paradise voted to approve Measure C enacting a sales and use tax revenue increase of one-half percent. The measure included the appointment of a nine-member oversight committee to make recommendations to the Council and then ensure the funds are allocated and invested as directed by the Council. The Town Clerk advertised for interested applicants and received fifty (50) applications.

At the January 13th Council Meeting, Council designated Mayor Bolin and Council Member Lotter to serve as a sub-committee to screen applications and interview applicants for the Measure C Citizen Oversight Committee for the purpose of providing a written recommendation for full Council review of their top twelve applicants for the oversight committee; authorized staff to set a special meeting to occur on February 24, 2015, at 6:00 p.m. in the Town Council Chamber for the Town Council to review the recommendation of the sub-committee and to make appointments to establish the nine-member Measure C Citizen Oversight Committee. Due to a potential conflict of interest and an unintended schedule conflict, Mayor Bolin was unable to serve on the selection subcommittee and Vice Mayor Jody Jones agreed to step in on his behalf.

Vice Mayor Jones and Councilmember Lotter carefully reviewed the 50 applications, decided upon a manageable list of qualified people who seemed to represent a good cross-section of the community. On February 6th and February 11th, the selection subcommittee met with the remaining 20 candidates.

During the initial interviews, each candidate was asked four questions:

- 1. What is your understanding of Measure C?
- 2. What experience or qualifications do you feel you would bring to this committee?
- 3. Name three positive things about Paradise and three things you don't like or think are lacking.
- 4. If a conflict arises on this committee what do you think is the best way to resolve it?

Discussion:

At the conclusion of the interviews, the selection sub-committee had another arduous and difficult task—to make a recommendation to the Town Council of the final twelve.


The finalists were selected based on (1) their qualifications, (2) being representative of the community and wanting what is best for the community, (3) holding accountability and transparency as top priorities, and (4) believing that a community is only as good as its citizens and knowing that by working together we can improve our Town. My education includes a degree in Fire Science from Butte College as well as numerous fire chief officer and law enforcement courses.


