## Measure C Oversight Committee Meeting Minutes 4:00 PM – July 26, 2016

### 1. OPENING

The July 26, 2016 regular meeting of the Measure C Oversight Committee was called to order by Vice Chair Molly Knappen at 4:05 p.m. who led the pledge of allegiance to the Flag of the United States of America.

**COMMITTEE MEMBERS PRESENT:** Chris Buzzard, Dean Fender, Dan Hansen, Nicki Jones, George Morris, Jr., Jim Ratekin and Molly Knappen, Vice Chair

**COMMITTEE MEMBERS ABSENT:** Sharon Simonton and Kirk Trostle, Chair.

**ALTERNATE PRESENT:** Linda Dye.

### 2. ITEMS

A spelling error was corrected on page two, "MOTION by **Fender**".

- a. **MOTION by Fender, seconded by Morris, Jr.**, approved the Minutes of the May 24, 2016 Measure C Committee Regular Meeting as amended. Roll call vote was unanimous; Simonton and Trostle absent and not voting.
- b. Finance Director/Town Treasurer Gina Will presented a financial update on 2015/2016 revenues and expenditures of the Measure C funds. Director Will stated that the budgeted revenues are likely to be approximately \$1.19 million which is over the budgeted amount of \$1,071 million. The expenditures are in line with the budgeted amounts.
- c. Town Engineer Marc Mattox presented an update on the Police Station Emergency Electrical/Generator Project.

**MOTION by Buzzard, seconded by Jones**, approved the general project that appears to be in compliance with the Measure C funding guidelines. Roll call vote was unanimous; Simonton and Trostle absent and not voting.

**MOTION by Morris, Jr., seconded by Hansen**, approved the 4<sup>th</sup> quarter financial report as presented. Roll call vote was unanimous; Simonton and Trostle absent and not voting.

- d. Town Engineer Marc Mattox provided an update on Measure C Road Projects.

There will also be a dedication of the Measure C Pearson Road Project. on Tuesday, August 2, 2016 near the Pearson Road and S. Libby Road intersection adjacent to Paradise Fire Station No. 82 (5545 S. Libby Road)

- e. Town Manager Lauren Gill informed the committee that the engine had been delivered to Sacramento and will be presented to the Town Council at the August 9<sup>th</sup> Town Council Meeting.
