Town of Paradise EOC Activation and Preparedness A Partial History 1990 - 2018

1990 – A major snowstorm causes numerous structural collapses including Thrifty Drug Store, Paradise Bowl, the Pine Cone Cannery and many smaller buildings. Additional structures are damaged, major roads are closed for days, power outages are widespread and in some areas last for over two weeks. One fatality results from a falling tree.

The Town and County activate their Emergency Operations Center's. A major effort is made by the Town to open roads, restore services and provide essential assistance to residents.

1990 – The Oakland Hills Fire kills 25 people and destroys over 3000 dwelling units. Landmark legislation by Senator Petris establishes ICS as the states official incident management system and requires its use by all public emergency responders. This bill also establishes Fire Hazard Severity Zones, Fire Safe Councils, requires the establishment of standards for building construction in Wildland Urban Interface Areas, and is the basis for the development of California's Standardized Emergency Management System (SEMS).

- **1992** The Maidu and Skyway fires threaten the Town during the week of September 20-26th pose a threat to the Town that require evacuations.
- 1993 The Town hires Carolyn Hayes and Associates to develop the Town's first disaster plan. With much assistance from staff, a disaster plan is published and adopted in 1993.
- **1995** Significant Snowstorm with partial EOC activation and the opening of a shelter.
- **1996** December 31st flooding results innumerous impacts within the Town. The EOC is partially activated.
- **1997** On January 1, 1997, major flooding in the valley lead to evacuations in Oroville and other south Butte County areas. Levee breeches lead to slow rise flooding in Yuba, Glenn, Sutter, and Sacramento Counties.

Town participates in County-wide earthquake exercise.

1998 - **The Town adopts the Wildland Fire Evacuation Plan**. The plan is mailed to all residents of Paradise and the Upper Ridge.

The Butte County Fire Safe Council is established.

1999 - A major lightning storm in August results in seven major fires in Butte County. Paradise is not directly impacted but dodges a bullet from a fire on Morgan Ridge below Town that nearly becomes an eighth major fire that would have directly threatened the Town.

"Wildland Urban Interface Management Plan" adopted by Town Council.

"Y2K Plan developed and implemented in preparation for impacts related to failures resulting computer failures on January 1, 2000.

"Town of Paradise Public Works Department Snow and Ice Control Plan" adopted by Town Council.

2000 - The September Concow Fire results in one fatality and burns 25 homes while threatening the Town of Paradise. The Town's EOC is activated and parts of southeast Paradise are activated.

The Town receives a grant to purchase a Hazard Advisory Radio System.

AM 1500 is Radio Station put in service.

Town conducts Functional Exercise of the EOC.

Congress passes the Disaster Management Act of 2000 (DMA 2000)requiring all communities to develop hazard assessments and risk mitigation by 2005.

2001 - The Poe Fire in September again threatens the Town of Paradise, requiring a activation of the EOC.

During the Poe Fire, the 911 tragedy occurs, bringing weapons of Mass Destruction into the community risk assessment process.

The Town receives a grant to purchase the "CityWatch" reverse 911 system.

2002 - The Town adopts the "Emergency Action Plan For Wildland Fire Evacuations". This plan is recognized by FEMA as an exemplary community preparedness document.

Town conducts Functional Wildland Exercise of the EOC during County-wide.

The Town establishes the Paradise Fire Safe Council.

2003 - Presidential Directive #5 requires the creation and implementation of the National Incident Management System (NIMS). This system is to be adopted nationwide by 2005. *Town conducts Tabletop Wildland Exercise in the EOC.*

2004 - The Town of Paradise purchases Incident Management Software for the EOC.

Mike Wrobel develops an Information Management Program for the EOC.

The Town installs projectors and white wall in the EOC to display the new Incident Management Programs.

Training is provided in the EOC on new Emergency Management Software.

The Town participates in a County-wide Disaster Tabletop Exercise in Chico.

2005 - The Town of Paradise joins a county-wide effort to meet DMA 2000 planning requirements.

The Town adopts NIMS as its Incident Management System to meet federal requirements for disaster funding eligibility.

Hurricane Katrina is an object lesson for lack of preparedness.

2006 - The Town of Paradise will participated in a County-wide full-scale EOC exercise.

The Town is planning monthly EOC training.

2008 – Full activation for a winter storm on January 5, 2008

2008 - Full EOC Activation for both the Humboldt Fire and the Butte Lightning Complex with debriefing and AAR
